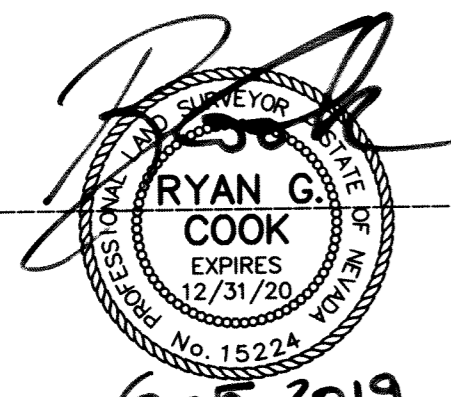


**SURVEYOR'S CERTIFICATE**

I, RYAN G. COOK, A PROFESSIONAL LAND SURVEYOR LICENSED IN THE STATE OF NEVADA, CERTIFY THAT:

1. THIS PLAT REPRESENTS THE RESULTS OF A SURVEY CONDUCTED UNDER MY DIRECT SUPERVISION AT THE INSTANCE OF RALPH CUDAS, ANTONIO TOGNONI, AND MIKE PODBORNY.
2. THE LANDS SURVEYED LIE WITHIN THE SOUTHWEST QUARTER OF SECTION 13 AND THE NORTHWEST QUARTER OF SECTION 24, TOWNSHIP 19 NORTH, RANGE 53 EAST, M.D.M. AND THE SURVEY WAS COMPLETED ON MAY 22, 2019.
3. THIS PLAT IS NOT IN CONFLICT WITH THE PROVISIONS OF N.R.S. 278.010 TO 278.630, INCLUSIVE, OR WITH PROVISIONS OF N.A.C. 625 AND ALL LOCAL ORDINANCES.
4. THE MONUMENTS DEPICTED ON THE PLAT ARE OF THE CHARACTER SHOWN, OCCUPY THE POSITIONS INDICATED AND ARE OF SUFFICIENT NUMBER AND DURABILITY.

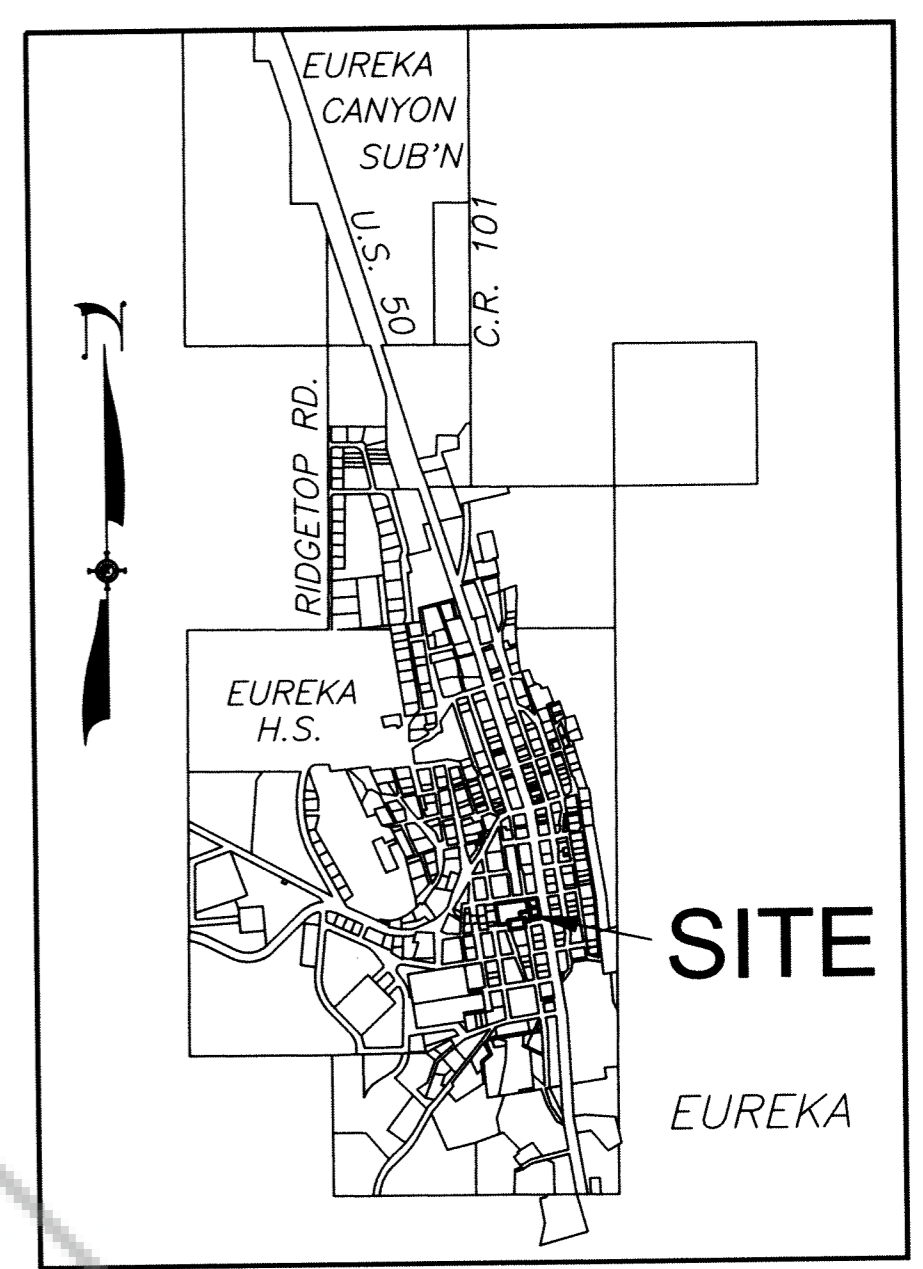
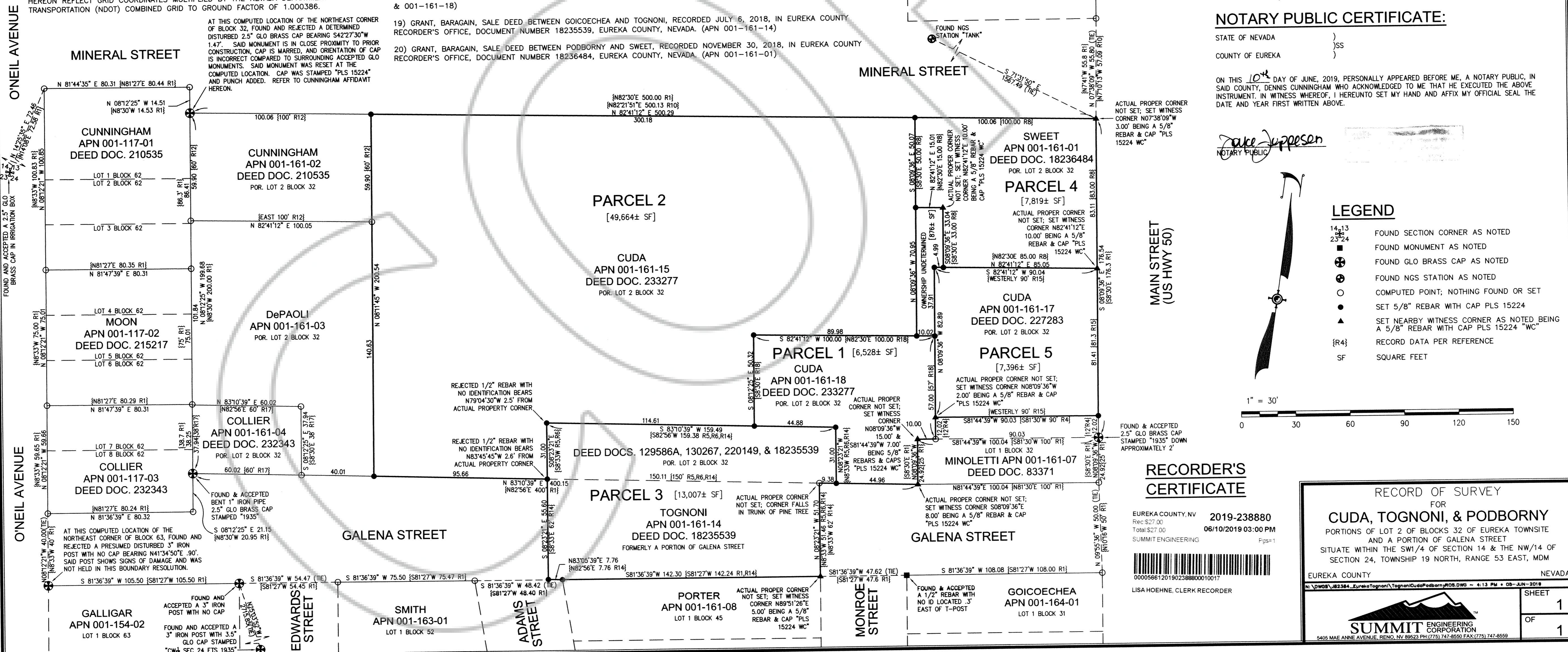

- 2) THIS RECORD OF SURVEY IS NOT IN CONFLICT WITH EXISTING ZONING REQUIREMENTS.
- 3) NO NEW PARCELS HAVE BEEN CREATED AS A RESULT OF THIS MAP.
- 4) GROSS AREA OF PARCEL 1 (APN 001-161-18) = 6,528± SQUARE FEET.
- 5) GROSS AREA OF PARCEL 2 (APN 001-161-15) = 49,664± SQUARE FEET.
- 6) GROSS AREA OF PARCEL 3 (APN 001-161-14) = 13,007± SQUARE FEET.

- 9) THE OWNER OF APN 001-161-07 DID NOT GRANT PERMISSION INTO THE WESTERLY REAR YARD TO ACCESS THE ACTUAL BOUNDARY POINTS NOTED HEREON.
- 10) BASIS OF BEARINGS: NORTH AMERICAN DATUM OF 1983 AS BASED ON FEDERAL BASE NETWORK/COOPERATIVE BASE NETWORK OBSERVATIONS IN 1994 (AKA NAD83/94), NEVADA STATE PLANE EAST ZONE. GROUND COORDINATES HEREON REFLECT GRID COORDINATES MULTIPLIED BY THE NEVADA DEPARTMENT OF TRANSPORTATION (NDOT) COMBINED GRID TO GROUND FACTOR OF 1.000386.

AT THIS COMPUTED LOCATION OF THE NORTHEAST CORNER OF BLOCK 32, FOUND AND REJECTED A DETERMINED DISTURBED 2.5" GLO BRASS CAP BEARING S42°27'30"W 1.47'. SAID MONUMENT IS IN CLOSE PROXIMITY TO PRIOR CONSTRUCTION, CAP IS MARRED, AND ORIENTATION OF CAP IS INCORRECT COMPARED TO SURROUNDING ACCEPTED GLO MONUMENTS. SAID MONUMENT WAS RESET AT THE COMPUTED LOCATION. CAP WAS STAMPED "PLS 15224" AND PUNCH ADDED. REFER TO CUNNINGHAM AFFIDAVIT HEREON.

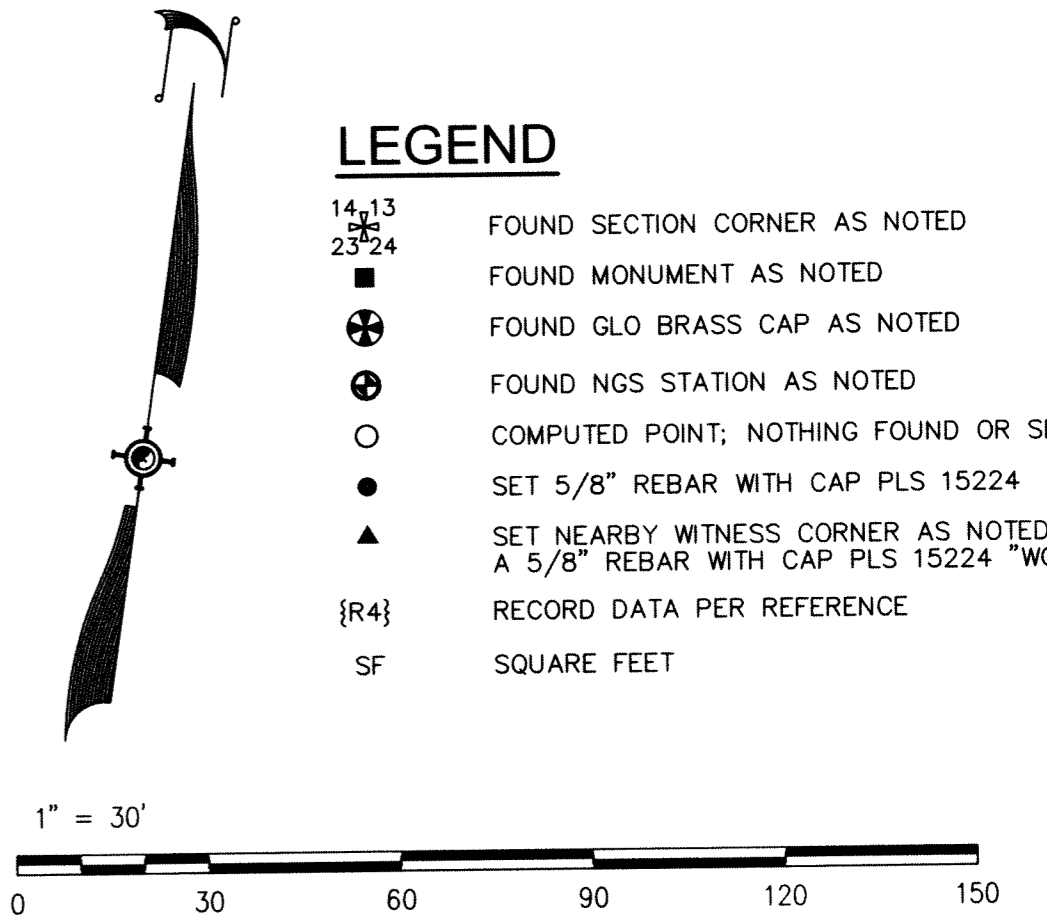
