### **ROYALTY DEED AND ASSIGNMENT**

Whereas Grantor wishes to convey to Grantee all of its right, title and interest in those royalty agreements described in Exhibit A attached hereto ("Royalty Agreements"). The Royalty Agreements affect properties situated in Elko, Eureka, and Humboldt Counties, Nevada.

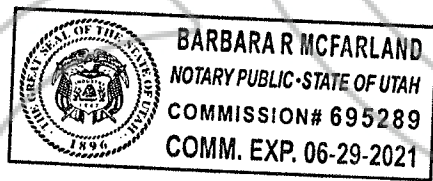
