**ASSIGNMENT AND ASSUMPTION AGREEMENT**

This ASSIGNMENT AND ASSUMPTION AGREEMENT (“**Assignment**”) is effective as of July 1, 2019 (“**Effective Date**”), by and between TIMBERLINE RESOURCES CORP., a Delaware corporation having an address of 101 E. Lakeside Ave., Coeur d’Alene, ID 83814 (“**Timberline**”), BH MINERALS USA, INC., a Colorado corporation having an address of 101 E. Lakeside Ave., Coeur d’Alene, ID 83814 (collectively with Timberline, “**Assignors**”), and LOOKOUT MOUNTAIN LLC, a Delaware limited liability company having an address of 101 E. Lakeside Ave., Coeur d’Alene, ID 83814 (“**Assignee**”). Assignors and Assignee are referred to herein each as a “**Party**” and collectively as the “**Parties**”. Capitalized terms used but not expressly defined in this Assignment shall have the meanings provided in the Contribution Agreement, dated effective as of July 1, 2019, among Timberline, Assignee, and PM&Gold Mines, Inc. (“**Contribution Agreement**”).

RECITALS

WHEREAS, Assignors own certain mining leases, mining agreements, surface use and damage agreements and other agreements covering all or part of those lands described on Exhibit A hereto (such lands, “**Properties**”, and such agreements covering the Properties, “**Agreements**”), including but not limited to those Agreements more particularly described on Exhibit B hereto; and

WHEREAS, pursuant to a Limited Liability Company Agreement of Lookout Mountain LLC dated June 28, 2019 (“**LLC Agreement**”) and the Contribution Agreement, Timberline has agreed to assign to Assignee, and Assignee has agreed to assume from Timberline, all of Assignors’ right, title, interests, and obligations in and under the Agreements to the extent such Agreements cover and relate to the Properties, pursuant to the terms and conditions set forth in the LLC Agreement and the Contribution Agreement.

NOW, THEREFORE, for good and valuable consideration as set forth in this Assignment (including these Recitals), the LLC Agreement and the Contribution Agreement, the receipt and sufficiency of which are hereby acknowledged by the Parties, Assignors and Assignee agree as follows:

AGREEMENT

- 1. Assignment and Assumption.

a. Assignors hereby assign, transfer and convey to Assignee, its successors and assigns, all of Assignors' rights, title, interests, and obligations in and to the Agreements to the extent that the Agreements cover and relate to the Properties.

b. This Assignment is made subject to all the terms, conditions and covenants of the Agreements. Assignee hereby acknowledges and agrees that Assignee assumes and agrees to perform and satisfy all of Assignors' obligations and responsibilities in and under the Agreements with respect to the Properties.

2. Terms of LLC Agreement and Contribution Agreement. This Assignment shall be interpreted in accordance with the terms and conditions set forth in the LLC Agreement and the Contribution Agreement, which LLC Agreement and Contribution Agreement shall govern in the event of a conflict between the terms hereof and those set forth in the LLC Agreement and the Contribution Agreement.

3. No Rights in Third Parties. Nothing expressed or implied in this Assignment is intended to confer upon any person, other than Assignors and Assignee and their respective successors and assigns, any rights, remedies, obligations or liabilities under or by reason of this Assignment, except as may be provided in the LLC Agreement or the Contribution Agreement.

4. Inurement. All covenants, conditions, limitations and provisions contained in this Assignment apply to, and are binding upon, the Parties and their respective heirs, representatives, successors and assigns.

5. Governing Law. This Assignment shall be construed, interpreted and enforced in accordance with the laws of the State of Nevada.

6. Waiver. No waiver of any provision of this Assignment, or waiver of any breach of this Assignment, shall be effective unless the waiver is in writing and is signed by the party against whom the waiver is claimed. No waiver of any breach shall be deemed to be a waiver of any other subsequent breach.

7. Recording. This Assignment shall be recorded in Eureka County, Nevada.

8. Rule Against Perpetuities. Any option or right to acquire any property interests under this Assignment shall be exercised, if at all, within the maximum time period allowed under any applicable rule against perpetuities or any analogous statutory or common law principle that is applicable.

9. Counterparts. This Assignment may be executed in any number of counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or other electronic means (e.g., electronic mail or PDF) shall be effective as delivery of a manually executed counterpart to this Assignment.






