
Orson Tingey, being duly sworn, says:

Being duly authorized, I make this affidavit on behalf of Genesis Gold Corp., #3 Knob Hill Road, Park City, Utah, 84098; and Nevada Gold Mines LLC, 1655 Mountain City Highway, Elko, Nevada, 89801.

1. 4. The serial number assigned to each Claim and Mill Site by the Bureau of Land Management is shown on Exhibit A.

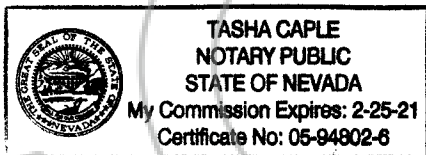


