NOTICE OF TERMINATION OF LIFE ESTATE


The undersigned, as the successor in interest to Placer Dome U.S. Inc., hereby states the following:

On or about December 5, 2005, by that certain Special Warranty Deed recorded on December 7, 2005 as Entry No. 202509 in Book 429 beginning at Page 39 of the Official Records of Eureka County, State of Nevada (the "**Official Records**"), William A. Curtis, Jr., as trustee of "Trust B" of the Curtis Family Trust of 2000, conveyed a life estate interest to William A. Curtis, Jr. ("**the Decedent**"), as beneficiary, in certain mining claims and other real property in Lander and Eureka Counties, Nevada, which interests are described more specifically in Exhibit A, attached hereto and incorporated by reference (collectively the "**Life Estate**").
2. On or about December 5, 2005, by that certain Special Warranty Deed recorded on December 7, 2005 as Entry No. 202510 in Book 429 beginning at Page 47 of the Official Records, Decedent conveyed the Life Estate to Placer Dome U.S. Inc., the predecessor of the undersigned.
3. Decedent was the measuring life of the Life Estate but has since died. The date and place of the Decedent's death are set forth in the death certificate that is attached hereto as Exhibit B and is incorporated herein by this reference.
4. All title or interest in and to the Life Estate has terminated and has reverted to the trustee of the "Trust B" of the Curtis Family Trust of 2000, who was the holder of the remainder interest.
5. The undersigned further disclaims any interest in and to the Life Estate.

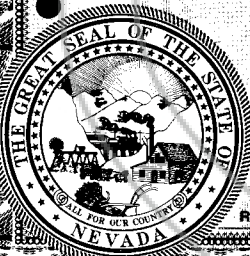
