

The undersigned hereby certifies under oaths and penalty of perjury pursuant to NRS 164.400 - 164.440, that the following facts are true:

1. JoAnn W. Curtis ("JoAnn") and William A. Curtis Jr. ("Curtis"), as Grantors and Co-Trustees, established the Curtis Family Trust of 2000 ("Family Trust") pursuant to a Declaration of Trust dated December 8, 2000 ("Family Trust Agreement").
2. JoAnn died on July 14, 2002, and after JoAnn's death, William A. Curtis Jr. became the sole Trustee of the Family Trust.
3. In accordance with the Family Trust Agreement, upon the death of JoAnn, the Family Trust split into more than one new, resulting trusts governed by the Family Trust Agreement, including Marital Trust – Trust B under the Curtis Family Trust of 2000 ("Marital Trust"). Curtis was the sole Trustee of all such resulting trusts, including the Marital Trust.
4. On or about December 11, 2012, William A. Curtis, Jr. resigned as the Trustee of the Marital Trust and was replaced by Whittier Trust Company of Nevada, Inc. ("Whittier") as Trustee of the Marital Trust.
5. On or about May 14, 2019, Whittier resigned as Trustee of the Marital Trust and was replaced by Steve S. Johnson as Trustee of the Marital Trust.
6. The undersigned, Steve S. Johnson, is the currently acting sole Trustee of the Marital Trust, and in that capacity has acquired, and is holding, all legal and equitable title to all assets of the Marital Trust formerly owned and held by Curtis and Whittier as the Trustee of the Marital Trust.
7. The Family Trust Agreement has not been revoked or amended to make any representations contained in the Certification incorrect.
8. The signature below is the signature of the only currently acting Trustee of the Marital Trust, Steve S. Johnson.

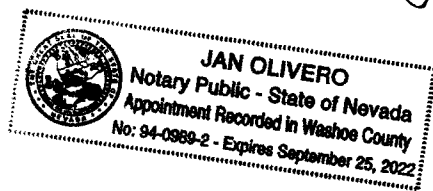
