**MEMORANDUM OF SIXTH AMENDMENT TO
MINING LEASE AND OPTION TO PURCHASE AGREEMENT**

This Memorandum of Sixth Amendment to Mining Lease and Option to Purchase Agreement (the "Memorandum"), dated effective as of November 4, 2016, is by and between **Mark Farley and J. Patrick Farley, Co-Trustees of THE ROBERT LEROY FARLEY AND GEORGIA LYNN FARLEY JOINT LIVING TRUST** (successor to the interest of Georgia Lynn Farley, widow of Robert L. Farley), and **Carl A. Farley and Donna L. Farley, Co-Trustees of THE CARL FARLEY and DONNA FARLEY TRUST**, (collectively the "**Farleys**"), and **NEVADA GOLD MINES LLC**, a Delaware limited liability company (NGM) (successor in interest to Barrick Gold Exploration Inc. and Newmont USA Limited, d/b in interest to Newmont Mining Corporation), (the "**Lessee**"). Farleys and Lessee are also collectively referred to herein as "**Parties**" and individually as a "**Party**".

RECITALS

A. The Farleys, as lessors and optionors, entered into a Mining Lease and Option to Purchase Agreement, dated effective as of November 4, 1991, (the "Initial Agreement"), pertaining to certain real property located in Eureka County, Nevada, which property is more particularly described in Exhibit A attached to and made a part of this Sixth Amendment (the "Property").

B. The Initial Agreement was amended by that certain First Amendment to the Agreement, dated September 1, 1996, extending the term of the Agreement to November 4, 2001, and that certain Second Amendment, dated October 30, 2001, extending the term of the Agreement to November 4, 2006, and that certain Fourth Amendment to the Agreement, dated October 30, 2006, extending the term of the Agreement to November 4, 2011, and that certain Fifth Amendment to the Agreement, dated October 30, 2011, extending the term of the Agreement to November 4, 2016 (collectively, the "Agreement"). Both Farleys and NGM acknowledge that the Third Amendment to the Agreement was inadvertently skipped and never initiated.

C. The parties have entered into a Sixth Amendment of Mining Lease and Option to Purchase Agreement dated as of November 4, 2016 (the "Sixth Amendment"). The Sixth Amendment extends the term of the Lease for an additional five years, until November 4, 2021. Lessee has the right to renew the Lease Term for one (1) additional terms of five (5) years.

PURPOSE OF MEMORANDUM

This Memorandum is prepared for the purposes of recording a notification as to the existence of the Agreement, as amended, but in no way modifies the express and particular provisions of the Agreement or the Sixth Amendment referred to above. In the event of a conflict between the terms of the Agreement, as amended, and the terms of this Memorandum, the terms of the Agreement, as amended, shall control. This Memorandum may be executed in any number of counterparts with the same effect as if the signatures thereto and hereto were upon the same instrument.
