## ASSIGNMENT AND ASSUMPTION MINING LEASE AND OPTION TO PURCHASE

(Eureka County)

This Assignment and Assumption, Mining Lease and Option to Purchase (this "Assignment") is made and entered into effective as of March //, 2020 (the "Effective Date"), by and between GREGORY McN. FRENCH, an individual ("Assignor"), and Nevada Select Royalty, Inc., a Nevada corporation ("Nevada Select").

- A. The Assignor is the record title owner of six (6) unpatented mining claims identified as the JAM 72 through 75, 85, and 86 claims situated in Eureka County, Nevada (the "JAM Claims"), which are more particularly described in Exhibit A.
- B. The JAM Claims are subject to that certain Mining Lease and Option to Purchase (JAM Claims) dated February 1, 2002 (the "JAM Lease"), among Assignor, as lessor, and McEwen Mining Nevada Inc., a Nevada corporation ("McEwen NV"), as successor-in-interest to White Knight Gold (U.S.) Inc., as lessee, and McEwen Mining Inc.
