ROYALTY DEED
(Ruby Hill Project)

This Royalty Deed (“**Deed**”) is made effective as of June 16, 2020, by and between RUBY HILL MINING COMPANY, LLC, a Nevada limited liability company (“**Payor**”), and ROYALTY CONSOLIDATION COMPANY, LLC, a Nevada limited liability company whose address for purposes of this Deed is c/o Elko Mining Group LLC, 9650 Gateway Drive, Suite 202, Reno, Nevada 89521 (“**Payee**”). Payor and Payee are collectively referred to herein as the “**Parties**” and individually as a “**Party**.”

Recitals

A. Payor is (1) the owner of the fee properties (the “**Owned Fee Property**”), the patented mining claims (the “**Owned Patented Claims**”) and the unpatented mining claims (the “**Owned Unpatented Claims**”) described in **Exhibit 1** hereto (collectively, the “**Owned Property**”), and (2) the lessee under those certain lease agreements described in **Exhibit 2** hereto (individually, a “**Lease**,” and collectively, the “**Leases**”), which Leases pertain to the patented and unpatented mining claims described in **Exhibit 2** hereto (collectively, the “**Leased Property**”). The Owned Property and the Leased Property are referred to herein collectively as the “**Properties**.” The Properties constitute what is generically known as the Ruby Hill project in Eureka County, Nevada.

B. Payor desires to grant, and Payee desires to receive, a mineral production royalty interest in the Properties, on the terms and conditions set forth in this Deed.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, incorporating the Recitals set forth above, undertake and agree as follows:

1. Grant of Royalty. Payor hereby grants to Payee and its successors, and covenants to pay to Payee and its successors, a nonparticipating Net Smelter Returns (as defined herein) production royalty on any sale of minerals from the Properties by Payor, to be calculated and paid in accordance with the provisions of **Exhibit 3** hereto (the “**Royalty**”). The Royalty (i) shall run with the Owned Fee Property and the Owned Patented Claims perpetually, (ii) shall run with the Owned

Unpatented Claims (including any amendments or modifications of the Owned Unpatented Claims, any replacements or relocations of the Owned Unpatented Claims or the ground therein, and any conversion of the Owned Unpatented Claims to another form of tenure) for so long as the Owned Unpatented Claims (or any amendments, modifications, replacements, relocations or conversions thereof) continue to exist, (iii) shall run with the relevant Leased Property for so long as the relevant Lease remains in effect, and (iv) shall be binding upon Payor and any successors to Payor. If Payor, or any successor, acquires the lessor's interest under a Lease, the Royalty and the obligation of Payor and its successors to pay the Royalty shall survive such acquisition regardless of whether the Lease is terminated, and the Royalty shall become a direct burden on the interest and related property that Payor so acquired. Payor agrees and covenants to execute and deliver a recordable instrument by which Payor grants to Payee the Royalty in any such acquired interest and property. On the amendment, modification, replacement, relocation or conversion to another form of tenure of any of the Owned Unpatented Claims, Payor agrees and covenants to execute and deliver a recordable instrument by which Payor subjects such amended, modified, replaced or relocated mining claims and the converted tenure, as applicable, to all of the burdens, conditions, obligations and terms of this Deed.

2. Royalty Rate. The rate of the Royalty shall be 4.5%; *subject, however,* to downward adjustment of that rate in respect of all portions of the Properties that were subject, as of the date of this Deed, to a mineral production royalty owned by or payable to any third party (each a "**Third-Party Royalty**"), regardless of whether such Third-Party Royalty was known or unknown to either Party at the time of this Deed and regardless of whether such Third-Party Royalty was or was not of record at the time of this Deed. As to those portions of the Properties that were subject to a Third-Party Royalty at the time of this Deed, the Royalty rate shall be the difference between 4.5% and the rate of the Net Smelter Returns equivalent of the Third-Party Royalty, but not less than zero. The Parties expressly agree that, if and to the extent that Payor's present grant of the Royalty would cause any part of the Properties to have a cumulative existing royalty burden in excess of 4.5% of the Net Smelter Returns (the "**Royalty Limit**"), then the Royalty rate shall be and is hereby permanently reduced as to that part of the Properties by the amount necessary to avoid exceeding the Royalty Limit. For example, if a portion of the Properties is subject to a Third-Party Royalty of or equivalent to 2.0% of the Net Smelter Returns, then the Royalty rate on that portion shall be only 2.5% (4.5% norm minus 2.0% Third-Party Royalty = 2.5% Royalty rate).

3. Maintenance of Properties. Payor shall maintain its title to the Owned Property and its leasehold interest in the Leased Property by, without limitation, paying when due all taxes on or with respect to the Owned Property, complying with all obligations of the Leases, and doing all things and making all payments necessary or appropriate to maintain the various rights, titles and interests of the Parties in and with respect to the Properties. Payor shall perform any required assessment work on, and pay all mining claim maintenance fees and make such filings and recordings as are necessary to maintain title to, all of the Owned Unpatented Claims and all unpatented mining claims covered by the Leases, in accordance with applicable federal and state laws and regulations, at least 30 days prior to the statutory or regulatory deadline for doing so, and shall, upon Payee's request, provide to Payee documentation of having timely done so. If Payor intends, at any time or from time to time, to (i) abandon or relinquish any of the Owned Unpatented Claims or (ii) terminate any Lease (the "**Abandonment Property**"), Payor in each and every case shall first give notice of such intention to Payee at least 30 days in advance of the

proposed date of abandonment, relinquishment or termination. At any time before the date of Payor's proposed abandonment, relinquishment or termination of the Abandonment Property, Payee may deliver notice to Payor (in accordance with Section 9 of **Exhibit 3** hereto) that Payee desires Payor to transfer all or some of the Abandonment Property to Payee. In each such case, Payor shall convey or assign, as the case may be, the relevant Abandonment Property to Payee by quitclaim deed or by assignment without warranty of title, as the case may be, in recordable form, for no further or additional consideration. If any such conveyance or assignment to Payee occurs within 60 days before the applicable statutory or regulatory deadline for performance of any required assessment work or for payment of mining claim maintenance fees for the relevant mining claims and filing and recording of the proof of such payment, then Payor shall nevertheless perform such obligations and pay all such fees for the relevant mining claims, notwithstanding the conveyance or assignment to Payee. If Payee does not timely request a conveyance or assignment of the Abandonment Property, Payee's right to do so shall be irrevocably terminated. On Payor's conveyance to Payee, assignment to Payee or authorized abandonment of the Abandonment Property, Payor's obligation to pay the Royalty shall terminate in respect of (but only in respect of) the Abandonment Property.

4. Transfer of Royalty. In its sole discretion, Payee may freely convey or otherwise transfer its ownership of the Royalty, in full or in part; provided, however, that no such conveyance or transfer shall be effective against Payor until Payor receives written notice of the conveyance or transfer in accordance with Section 9 of **Exhibit 3** hereto.

5. No Merger. The Parties acknowledge and agree that, while they and/or their successors are or may become affiliated entities, the Royalty shall never be terminated implicitly or impliedly through the doctrine of merger of title.

6. Further Assurances. Each Party agrees hereafter to execute and deliver, from time to time, such additional documents and to take such further actions as may be necessary to fully implement the transactions contemplated by this Deed.

7. No Partnership. Nothing in this Deed shall be construed to create, expressly or by implication, a joint venture, mining partnership or other partnership relationship between the Parties.

8. Authorization. Each Party represents and warrants to the other that (a) it is an entity in good standing under the laws of the state of its formation noted above and is duly authorized to conduct business in the state of Nevada, (b) the person signing this Deed on its behalf has full and proper authority to do so, (c) it has undertaken and obtained whatever internal formalities, approvals and actions are necessary to enter into this Deed, and (d) this Deed is valid and binding on it.

9. Governing Law. This Deed, and any causes of action arising out of or based upon this Deed, shall be governed by, and construed, interpreted and enforced in accordance with, the laws of Nevada, without regard to choice or conflict of law principles that would result in the application of the laws of any other jurisdiction. Each Party irrevocably consents, on behalf of itself and its successors, to the exclusive jurisdiction of the courts of the state of Nevada or the federal

district court for the District of Nevada, as may be applicable, in respect of any disputes arising hereunder, with venue to be in Washoe County.

10. Binding Effect. This Deed shall inure to the benefit of and be binding upon the Parties and their respective successors.

11. Execution. This Deed may be executed in multiple counterparts, which taken together shall constitute one and the same document.

12. Rule Against Perpetuities. The Parties do not intend or desire for this Deed to violate the common law Rule against Perpetuities or any analogous statutory provision or any other constitutional, statutory or common law rule imposing time limits on the vesting or termination of estates in land. If any provision of this Deed does or would violate the Rule against Perpetuities or any analogous statutory provision or any other constitutional, statutory or common law rule imposing time limits on the vesting or termination of estates in land, then this Deed shall not be deemed void or voidable, but shall be interpreted in such a way as to maintain and carry out the Parties' objectives to the fullest extent possible by law.

Royalty

1. “**Net Smelter Returns**” means the proceeds actually received, or deemed to have been received in the case of refined gold and silver as described in Section 1.a below, from the sale or deemed sale of any and all ores, metals, minerals (of whatsoever kind) and mineral products (“**Mineral Substances**”) produced from the Properties, less the charges (and only the charges) described in Section 1.b below.

a. If Payor sells refined gold or silver, Payor shall be deemed to have received proceeds from the sale thereof equal to the number of ounces of refined gold or silver returned to Payor’s account during the calendar quarter multiplied in the case of gold by the average daily afternoon LBMA Gold Price (formerly known as the London Bullion Brokers P.M. Gold Fixing) during such calendar quarter and in the case of silver by the average of the daily Handy & Harmon Noon Silver Quotation during the calendar quarter. The average price for a calendar quarter shall be determined by dividing the sum of all daily prices posted during the calendar quarter by the number of days that prices were posted. The posted price shall be obtained from the *Wall Street Journal*, *Reuters*, *E&MJ* or other industry-accepted source. Payor shall have the right to market and sell to third parties refined gold and silver in any manner it chooses, including the sale of such refined gold and silver on the commodity market. In this regard, Payee shall have no right to participate in any gains and/or profits or obligation to suffer any losses accruing to Payor as a result of forward sales, options trading, commodities futures trading or similar transactions.

b. Charges to be deducted from proceeds in determining Net Smelter Returns are the following:

(1) all costs, charges and expenses paid or incurred by Payor for treatment in the smelting and refining processes (including handling, processing, interest and provisional settlement fees, sampling, assaying and representation costs, penalties and other processor deductions);

(2) all costs, charges and expenses paid or incurred by Payor for transportation of Mineral Substances from the Properties to the place or places of treatment and thence to the place or places of sale (including freight, insurance, security, transaction taxes, handling, port, demurrage, delay and forwarding expenses incurred by reason of or in the course of such transportation);

(3) sales and brokerage costs on the Mineral Substance for which the Royalty is payable; and

(4) sales, use, severance, net proceeds of mine, and ad valorem taxes applicable under local, state and federal law and any other tax or governmental levy or fee relating to the Mineral Substance for which the Royalty is payable (other than taxes based upon income).

For the avoidance of doubt, in calculating Net Smelter Returns there shall be no deduction for any

costs of mining, or any costs of transporting Mineral Substances to the mill or other processing site, or any costs of processing Mineral Substances other than said smelting and refining costs. If any sale of Mineral Substances is to an affiliate of Payor or is otherwise less than an arm's length transaction, the amount of proceeds for determining Net Smelter Returns shall not be less than the amount that would have been received in an arm's length transaction. Likewise, if any charge in determining Net Smelter Returns is payable to an affiliate of Payor or is otherwise less than an arm's length transaction, the amount of the charge shall not be more than the amount that would have been charged in an arm's length transaction.

2. Royalties shall accrue quarterly (based on calendar quarters) and shall become due and payable by Payor on the last day of the month following the end of each quarter. All Royalty payments shall be calculated on the basis of and paid in United States Dollars. Royalty payments shall be accompanied by pertinent information in sufficient detail to explain the calculation of the Royalty payment.

3. Except in the case of fraud or intentional misrepresentation, all statements for royalties rendered to Payee by Payor during any quarter shall conclusively be presumed to be true and correct after one year following the end of such quarter unless within said one-year period Payee takes written exception thereto and makes a claim on Payor for adjustment. No adjustment favorable to Payor shall be made unless the claim therefor is made within the same prescribed period.

4. Payee, upon notice in writing to Payor, shall have the right to audit Payor's accounts and records relating to the amount, method of calculation and payment of the Royalty for any calendar quarter within the one-year period following the end of such calendar quarter; provided, however, that the making of any audit shall not extend the time for the taking of written exception to and the adjustment of accounts as provided for in the preceding paragraph. All audits shall be conducted by Payee at the office of Payor where the relevant books and records are maintained and shall be conducted during normal business hours. Each audit shall be undertaken at Payee's sole cost and expense; provided, however, that should the audit of any Royalty payment reveal a deficiency of 5.0% or more between the amount that should have been paid by Payor to Payee in respect of the corresponding calendar quarter and the amount actually paid, Payor shall reimburse Payee for all costs and expenses incurred in undertaking such audit.

5. Payor shall allow Payee, at its risk and expense, access to the Properties for the purposes of viewing and inspecting Payor's operations (including any stage when Mineral Substances are mined, handled, stored, treated, weighed, sampled, assayed, moisture-determined or commingled), at times that do not unreasonably interfere with Payor's operations. Payee agrees to indemnify and hold harmless Payor from and against all claims, demands and liabilities arising from or relating to such inspections, except to the extent caused by Payor's gross negligence or willful misconduct.

6. Payor shall have the right to mine amounts of Mineral Substances reasonably necessary for sampling, assaying, metallurgical testing and evaluation of the mineral potential of the Properties without incurring any obligation to make Royalty payments; provided, however, that if Payor sells such Mineral Substances or products produced therefrom, Payor shall be required to pay

the Royalty on all such Mineral Substances or products sold.

7. Payor shall have the right to commingle ore removed from the Properties or products derived therefrom after treatment, with other ore or products, before or after concentration or beneficiation, so long as the data necessary to determine the weight, grade and recoverability of both the ore removed from the Properties or products derived therefrom and the ore or products with which it is commingled are obtained by Payor. Payor shall then use that data to determine Payee's interest in minerals extracted from ores or products so mixed. Such data and determinations shall be acquired and completed in accordance with generally accepted industry practices.

8.
