Being duly authorized, I make this affidavit on behalf of NuLegacy Gold Corporation NV, a Nevada corporation ("Company"), and am personally acquainted with matters described herein.

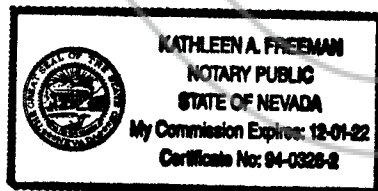
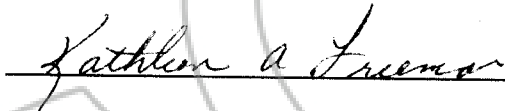
