The undersigned gives notice and swears as follows:

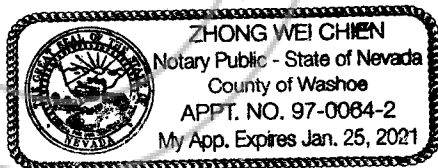
