### Memorandum of Purchase Agreement WW Claims

This Memorandum of Purchase Agreement WW Claims (“Memorandum”) is made and entered into by and among General Moly, Inc., a Delaware corporation (“General Moly”), and Eureka Moly LLC, a Delaware limited liability company (“Seller”) (General Moly and Seller collectively “Moly”), and Golden Pick LLC, a Nevada limited liability company (“GPLLC”), McEwen Mining Inc., a Colorado corporation (“MMI”), and McEwen Mining Nevada Inc., a Delaware corporation (“Buyer” or “MMNI”) (GPLLC, Buyer and MMI collectively “McEwen”). The parties have entered the Purchase Agreement WW Claims dated the date stated below pursuant to which Seller agreed to sell to Buyer and Buyer agreed to purchase certain unpatented mining claims, to provide for certain limitations, rights and obligations concerning access to and activities on their unpatented mining claims and to provide for McEwen to grant to Seller a mineral production royalty as provided in the Deed of Royalty dated the date of this Memorandum.

The unpatented mining claims subject to the Agreement and this Memorandum are:

- A. The WW 17 to WW 19, WW 25 – WW 42, WW 45 – WW 46, WW 50 – WW 61, WW 70 – WW 76 and WW 80 – WW 86 unpatented mining claims situated in Eureka County, Nevada, more particularly described in Exhibit A attached to and by this reference incorporated in this Agreement (collectively the “WW Claims”).
- B. The Soren 17, 18, 35, 36 and 53 unpatented mining claims situated in Eureka County, Nevada, more particularly described in Exhibit B, Part 1, attached to and by this reference incorporated in this Agreement (collectively the “Soren Claims”).
- C. 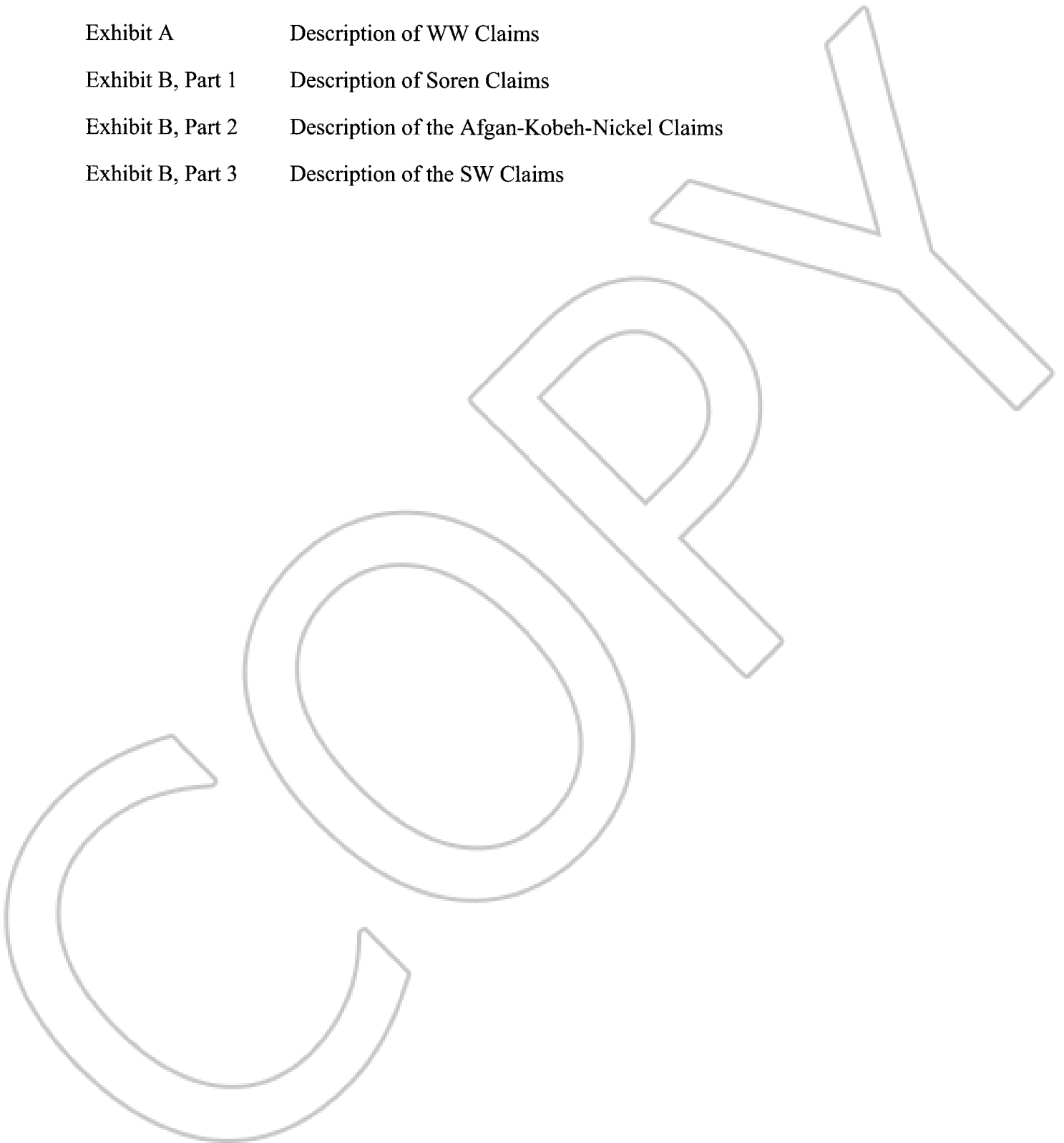

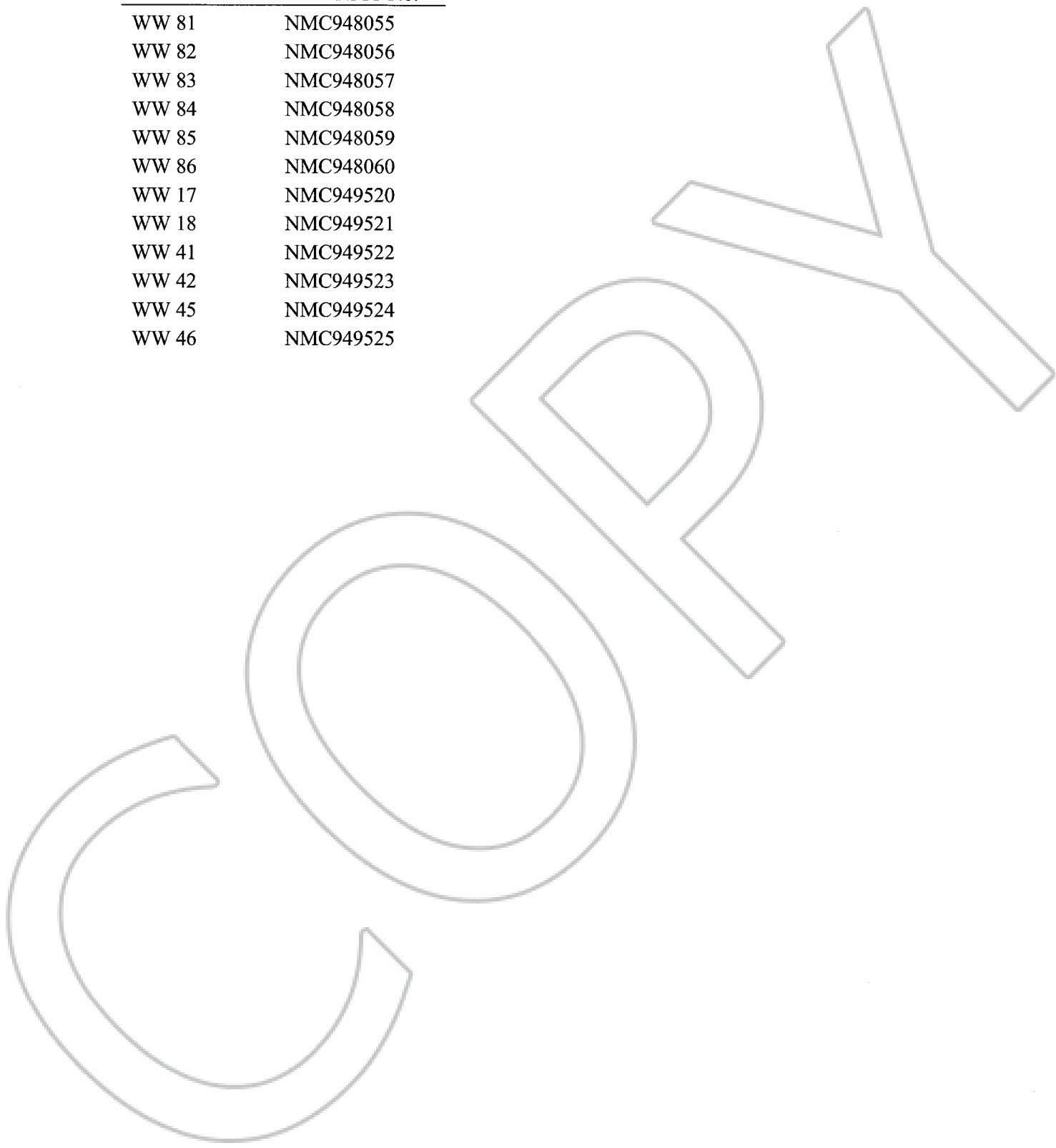
