the Claims and Mill Sites. It is the owner's intention to hold each of the Claims and Mill Sites through the assessment year ending September 1, 2021.

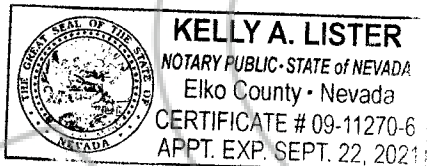
