The general course of the lode or vein is from the **North** to the **South** direction.

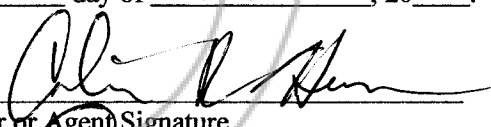
