Assignor now wishes to assign the Scoonover Royalty to Assignee.



SPECIAL WARRANTY DEED WITH RESERVED ROYALTY

THIS SPECIAL WARRANTY DEED WITH RESERVED ROYALTY is made , 2015, by and between SCOONOVER EXPLORATION, a Nevada limited liability company ("Grantor"); and GOLDEN PICK LLC, a Nevada limited liability company("Grantee"). Grantor and Grantee are collectively referred to as the "Parties."

WITNESSETH:

Conveyance of Unpatented Mining Claims. Grantor, in consideration of the sum of TEN DOLLARS (\$10.00) and other valuable consideration paid to it by Grantee, does hereby remise, release, and convey unto Grantee all of Grantor's right, title, and interest in and to the one hundred and ten (110) unpatented lode mining claims situated in the Eureka County, Nevada, which are more particularly described on Exhibit A attached hereto (the "Claims").

TOGETHER with all and singular the tenements, hereditaments and appurtenances

thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TOGETHER with all minerals and all veins and lodes of mineral-bearing rock therein and all dips, spurs and angles thereof.

TO HAVE AND TO HOLD all of the right, title and interest of Grantor in and to the Claims, together with the appurtenances, unto Grantee, its successors and assigns forever.

- 2. <u>Warranties and Representations</u>. Grantor makes the following warranties and representations to Grantee with respect to this conveyance, and no other:
- a. Grantor owns and possesses the Claims free and clear of all liens and encumbrances created by Grantor.
 - b. Grantor has the right to convey the Claims to Grantee.
- c. Grantor has no knowledge of any litigation or environmental liabilities affecting the Claims, and Grantor has not received any notices from local, state, or federal agencies regarding environmental hazards or other problems associated with the Claims.
- 3. Reserved Royalty on Production. Upon commencing production of valuable minerals from the Claims, Grantee shall pay Grantor a royalty on production equal to one percent (1 %) of Net Smelter Returns (as defined herein) on all ores and minerals produced from the Claims. The term "Net Smelter Returns" shall mean the gross value of ores or concentrates shipped to a smelter or other processor (as reported on the

smelter settlement sheet) less the following expenses actually incurred and borne by Grantee:

- (a) Sales, use, gross receipts, severance, and other taxes, if any, payable with respect to severance, production, removal, sale or disposition of the minerals from the Property, but excluding any taxes on net income;
- (b) Charges and costs, if any, for transportation from the mine or mill to places where the minerals are smelted, refined and/or sold; and
- (c) Charges, costs (including assaying and sampling costs specifically related to smelting and/or refining), and all penalties, if any, for smelting and/or refining.


In the event smelting or refining are carried out in facilities owned or controlled, in whole or in part, by Grantee, charges, costs and penalties for such operations shall mean the amount Grantee would have incurred if such operations were carried out at facilities not owned or controlled by Grantee then offering comparable services for comparable products on prevailing terms.

Payment of production royalties shall be made not later than thirty (30) days after receipt of payment from the smelter. All payments shall be accompanied by a statement explaining the manner in which the payment was calculated.

4. <u>Inspection of Property</u>. Grantor, or Grantor's authorized agents or representatives, shall be permitted to enter upon the Property at all reasonable times for the purpose of inspection, but shall enter upon the Claims at Grantor's own risk and so as not

to hinder unreasonably the operations of Grantee. Grantor shall indemnify and hold Grantee harmless from any damage, claim, or demand by reason of injury to Grantor or Grantor's agents or representatives on the Property or the approaches thereto.

5. <u>Inspection of Accounts</u>. Grantee agrees to keep accurate books of account reflecting the mining operations on the Claims, and Grantor shall have the right, either personally or through a qualified accountant of Grantor's choice and at Grantor's cost, to examine and inspect the books and records of Grantee pertaining to the mining, milling and shipping operations of Grantee.
