**AMENDMENT OF AMENDED AND RESTATED MORTGAGE,
ASSIGNMENT OF PRODUCTION, SECURITY AGREEMENT,
FINANCING STATEMENT AND FIXTURE FILING**

THIS AMENDMENT OF AMENDED AND RESTATED MORTGAGE, ASSIGNMENT OF PRODUCTION, SECURITY AGREEMENT, FINANCING STATEMENT AND FIXTURE FILING (this "Amendment"), dated as of March 24, 2021, is by and among GRANT CANYON OIL & GAS, LLC, a Colorado limited liability company ("GCOG"), individually and as successor by merger to Aviara Oil & Gas, LLC, with an address at 717 Seventeenth Street, Suite 1400, Denver, Colorado 80202, PINE VALLEY OIL & GAS, LLC, a Colorado limited liability company ("PVOG"), with an address at 3300 South Columbine Circle, Englewood, Colorado 80113, and JONAH BANK OF WYOMING, a Wyoming corporation ("Jonah Bank"), with an address at 205 Storey Blvd., Cheyenne, Wyoming 82009.

RECITALS

A. GCOG and Aviara Oil & Gas, LLC ("Aviara") executed and delivered to Jonah Bank an Amended and Restated Mortgage, Assignment of Production, Security Agreement, Financing Statement and Fixture Filing dated as of March 9, 2018 (the "A/R Mortgage"). Capitalized terms used herein but not defined herein shall have the same meanings as set forth in the A/R Mortgage. The A/R Mortgage was filed and recorded as follows:

B. Effective as of January 1, 2019, Aviara and GCOG merged, with GCOG being the surviving entity. The Statement of Merger was filed and recorded as follows:

C. GCOG, PVOG and Jonah Bank desire to amend the A/R Mortgage to remove Aviara as a mortgagor, to add PVOG as an additional mortgagor thereunder and to add to the collateral covered by the A/R Mortgage certain interests in oil and gas leases, lands, wells, fixtures, equipment, Hydrocarbons, accounts and related property and interests, some of which are owned by PVOG and some of which are owned by GCOG.

AMENDMENT

In consideration of Ten Dollars and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, GCOG, PVOG and Jonah Bank agree that the A/R Mortgage shall be, and hereby is, amended as follows:

1. Aviara shall be removed as a mortgagor under the terms of the A/R Mortgage; provided that the properties, rights and interests that had been owned by Aviara prior to its merger into GCOG shall continue to be covered by the A/R Mortgage, although now owned by GCOG, as successor by merger to Aviara.

2. PVOG shall be added as an additional mortgagor under the terms of the A/R Mortgage, and all references in the A/R Mortgage to "Mortgagor" shall be deemed to refer collectively to GCOG and PVOG.

3. Exhibit "A" attached to the A/R Mortgage shall be supplemented by adding thereto all of the right, title and interest of PVOG in and to certain leases, wells and associated interests, some of which leases and wells are already described in Exhibit "A" attached to the A/R Mortgage because GCOG has previously mortgaged its interest therein to Jonah Bank, in which case the interests of PVOG in and to said leases, wells and associated interests are intended to be covered by the A/R Mortgage in addition to the previously-mortgaged interests of GCOG. The interests of PVOG being added to the A/R Mortgage pursuant hereto (the "2021 PVOG Collateral"), all of which are related to lands located in Nye County, Nevada, are comprised of all right, title and interest of PVOG in and to the following: (a) the oil and gas leases described in Parts 1, 2 and 3 of Exhibit "A" attached hereto and made a part hereof (the "2021 PVOG Leases") covering the lands described in Parts 1, 2 and 3 of Exhibit "A" attached hereto (the "2021 PVOG Lands"), (b) the oil and gas wells described in Part 4 of Exhibit "A" attached hereto (including, but not limited to, the Working Interests and Net Revenue Interests described therein), together with any and all other wells in which PVOG may now or hereafter own an interest and which are now or hereafter located on any of the 2021 PVOG Lands (all of the foregoing being hereinafter referred to as the "2021 PVOG Wells"), and (c) to the extent that they relate to any or all of the 2021 PVOG Leases, the 2021 PVOG Lands or the 2021 PVOG Wells, all fixtures, equipment, Hydrocarbons, accounts and other property and interests of the types referenced in the definition of "Mortgaged Property" contained in the A/R Mortgage.

4. Exhibit "A" attached to the A/R Mortgage shall be further supplemented by adding thereto all of the right, title and interest of GCOG in and to certain leases, wells and associated interests, which leases and wells are in addition to those already described in Exhibit "A" attached to the A/R Mortgage. The interests of GCOG being added to the A/R Mortgage pursuant hereto (the "2021 GCOG Collateral"), all of which are related to lands located in Eureka County, Nevada, are comprised of all right, title and interest of GCOG in and to the following: (a) the oil and gas leases described in Part 1 of Exhibit "B" attached hereto and made a part hereof (the "2021 GCOG Leases") covering the lands described in Part 1 of Exhibit "B" attached hereto (the "2021 GCOG Lands"), (b) the oil and gas wells described in Part 2 of Exhibit "B" attached hereto (including, but not limited to, the Working Interests, Net Revenue Interests and Overriding Royalty Interests described therein), together with any and all other wells in which GCOG may now or hereafter own an interest and which are now or hereafter located on any of the 2021 GCOG Lands (all of the foregoing being hereinafter referred to as the "2021 GCOG Wells"), and (c) to the extent that they relate to any or all of the 2021 GCOG Leases, the 2021 GCOG Lands or the 2021 GCOG Wells, all fixtures, equipment, Hydrocarbons, accounts and other property and interests of the types referenced in the definition of "Mortgaged Property" contained in the A/R Mortgage.

5. All references in the A/R Mortgage to the "Leases" shall be deemed to refer to the Leases originally described in the A/R Mortgage, the 2021 PVOG Leases and the 2021 GCOG Leases. All references in the A/R Mortgage to the "Lands" shall be deemed to refer to the Lands originally described in the A/R Mortgage, the 2021 PVOG Lands and the 2021 GCOG Lands. All references in the A/R Mortgage to the "Wells" shall be deemed to refer to the Wells originally described in the A/R Mortgage, the 2021 PVOG Wells and the 2021 GCOG Wells. All references in the A/R Mortgage to the "Mortgaged Property" shall be deemed to include the Mortgaged Property originally described in the A/R Mortgage, the 2021 PVOG Collateral and the 2021 GCOG Collateral.

GRANT BY PVOG

PVOG hereby:

A. Grants, bargains, sells, assigns, transfers, pledges, mortgages and grants a security interest in the 2021 PVOG Collateral to Jonah Bank and its successors and assigns forever, subject to all of the terms, conditions, covenants and agreements set forth in the A/R Mortgage, as amended hereby, WITH POWER OF SALE pursuant to the A/R Mortgage, as amended hereby, and applicable law, TO HAVE AND TO HOLD the 2021 PVOG Collateral to Jonah Bank and its successors and assigns; and

B. Assigns to Jonah Bank all of the severed and extracted Hydrocarbons produced from or attributable to any of the 2021 PVOG Collateral, together with all amounts that become payable to PVOG with respect to any of the 2021 PVOG Collateral, and all of the proceeds thereof.

GRANT BY GCOG

GCOG hereby:

A. Grants, bargains, sells, assigns, transfers, pledges, mortgages and grants a security interest in the 2021 GCOG Collateral to Jonah Bank and its successors and assigns forever, subject to all of the terms, conditions, covenants and agreements set forth in the A/R Mortgage, as amended hereby, WITH POWER OF SALE pursuant to the A/R Mortgage, as amended hereby, and applicable law, TO HAVE AND TO HOLD the 2021 GCOG Collateral to Jonah Bank and its successors and assigns; and

B. Assigns to Jonah Bank all of the severed and extracted Hydrocarbons produced from or attributable to any of the 2021 GCOG Collateral, together with all amounts that become payable to GCOG with respect to any of the 2021 GCOG Collateral, and all of the proceeds thereof.

MISCELLANEOUS

This Amendment shall bind and inure to the benefit of the respective successors and assigns of GCOG, PVOG and Jonah Bank, or any of them. Each of GCOG and PVOG hereby ratifies, confirms and adopts the A/R Mortgage, as amended hereby. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same instrument.

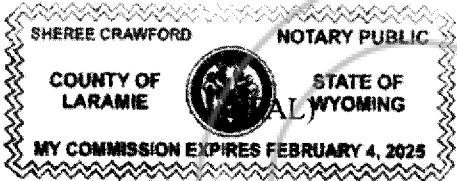
