Located the **Devils Canyon-037** Lode Mining Claim in the following quarter section(s):

The claim is approximately 1500 feet long and 600 feet wide, such that 10 feet are claimed in the East direction and 1490 feet in the West direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the claim.
