Located the **Devils Canyon-037** Lode Mining Claim in the following quarter section(s):
SW/4, Section 24, Township 25 North, Range 54 East, MDB&M
in Eureka County, Nevada, on the 22nd day of June, 2021.

The claim is approximately 1500 feet long and 600 feet wide, such that 10 feet are claimed in the East direction and 1490 feet in the West direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the claim. The general course of the lode or vein is from the north to the south direction.
