
### Notice of Intent to Hold and Affidavit of Payment of Fees

5. This Notice includes sixteen (16) unpatented mining claims.

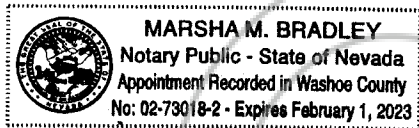
