By the grace of God and the Apostolic See in the first year of the Pontificate of Francis, Reverend Daniel Henry Mueggenborg was appointed July 20, 2021, eighth Bishop of Reno, Nevada.

Father Mueggenborg was ordained a priest of the Diocese of Tulsa on July 14, 1989.

Father Mueggenborg was installed as the eighth bishop of Reno on September 24, 2021, in Reno, Nevada by Metropolitan Archbishop Salvatore J. Cordileone of San Francisco. The installation took place in the presence of Archbishop Pierre Christophe, Apostolic Nunciature of the United States of America, Cardinal Roger Mahony, Archbishop Emeritus of Los Angeles, and 1195 persons who participated in the liturgy.
