CONSENT AND ASSIGNMENT AGREEMENT

(Real Property Lease)

(South Arturo)

This Consent and Assignment Agreement (Real Property Lease) (South Arturo) (this "Assignment"), executed to be effective as of October 14, 2021 ("Effective Date"), is by and among Goldcorp Dee LLC, a Nevada limited liability company, whose address is 5190 Neil Road, Suite 110, Reno, NV 89502 ("Assignor"), Nevada Gold Mines LLC, a Delaware limited liability company, whose address is 1655 Mountain City Highway, Elko, Nevada 89801 ("Assignee"), and Franco-Nevada U.S. Corporation, a Delaware corporation, whose address is 1745 Shea Center Drive, Suite 400, Highlands Ranch, CO 80129 ("Lessor").

Recitals

A. Lessor and Assignor are successors in interest to the parties to that certain Lease Agreement by and between Phillip A. Davis and J.S. Livermore, dba Cordex Exploration Co., dated June 26, 1981, as amended (the "Lease"), more particularly described in Exhibit A. Pursuant to notice delivered to the Lessor dated July 26, 2021, the term of the Lease was extended for five years, commencing September 26, 2021. Pursuant to the terms of the Lease, Lessor's consent ("Consent") is required to assign any of Assignor's interest in the Lease to a third party.

B. Assignor and Assignee are parties to that certain Exchange Agreement dated September 3, 2021, as amended (the "Agreement"), pursuant to which, Assignor agreed, among other things, to assign to Assignee all of Assignor's right, title and interest in, to and under the Lease. A list of the unpatented claims that are subject to the Lease is described in Exhibit B.

C. Pursuant to the Agreement, the parties to the Agreement agreed, among other things, to cause Assignee to assume all Assignor liabilities in, under or related to the Lease, as described in the Agreement.

D. The WDC 1 - WDC 31 unpatented mining claims, located by Assignee's predecessor-in-interest on June 6, 2013 in the name of Lessor in accordance with the terms of the Lease, are located within the area of interest described in the Lease but have not been formally added to the list of unpatented mining claims covered by the Lease (the "WDC Claims").

E. Assignor and Assignee execute this Assignment with respect to the Lease in order to fulfill, in part, their obligations under the Agreement. Lessor executes this Assignment in order to Consent to the assignment of Assignor's interest in the Lease to Assignee and to affirm the location of the WDC Claims under the Lease. The Lease relates to real property located in Elko and Eureka Counties, Nevada.

Assignment and Assumption

1. For good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, and subject to the terms and conditions set forth in the Agreement, Assignor sells, assigns and transfers to Assignee, its successors and assigns forever, all of Assignor's right, title and interest in, to and under the Lease, free and clear of all Encumbrances other than Permitted Encumbrances, to have and to hold forever.

2. As of the Effective Date, Assignee accepts the assignment, and assumes and agrees to perform and satisfy all Assignor liabilities in, under or related to the Lease.

3. Lessor Consents to the assignments and assumptions provided herein and recognizes Assignee as the lessee under the Lease and agrees that Assignee shall be entitled to all of the rights of the lessee under the Lease.

4. Lessor and Assignee agree to amend the Lease to add the WDC Claims to the Lease. All of the unpatented mining claims owned by Lessor and leased to the lessee pursuant to the Lease as of the Effective Date, including the WDC Claims, are set forth on Exhibit B attached hereto and incorporated herein by reference.

7. This Assignment and the covenants contained herein shall extend to and be binding upon and every benefit hereof shall inure to the parties hereto, their respective successors and assigns. This Assignment is intended to and does convey any after acquired title or interest in and to the Lease that Assignor may hereafter acquire.

8. This Assignment, being further documentation of the transactions contemplated by the Agreement, is subject in all respects to the terms and conditions of the Agreement. In the event of a conflict between any provision of this Assignment and any provision of the Agreement, the provisions of the Agreement shall control. Capitalized terms used but not defined in this Assignment shall have the meanings ascribed to them in the Agreement.

9. This Assignment shall be governed by the laws of the State of Nevada.

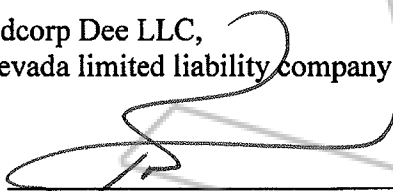
