**Assignment and Assumption  
Carlin-East Project**

This Assignment and Assumption Carlin-East Project (this "Assignment") is made and entered effective as of the date stated below (the "Effective Date") by and between Carlin East LLC, a Nevada limited liability company ("Assignor"), and Ridgeline Minerals Corporation, a Nevada corporation ("Assignee").

A. Assignor and Assignee are parties to the Exploration and Option Agreement (Carlin-East Project) dated April 10, 2019, as amended by the First Amendment to Exploration and Option Agreement dated August 10, 2020 (the "Option Agreement"), pursuant to which the parties agreed, among other things, that Assignor would convey to Assignee title to certain unpatented mining claims situated in Elko County and Eureka County, Nevada, and Assignor would assign to Assignee Assignor's rights in and under the Lease and Option Agreement (Unpatented Mining Claims) dated August 8, 2017 (the "Lease"), between Genesis Gold Corp., a Utah corporation ("Genesis"), as lessor, and Assignor, as lessee, in accordance with which Genesis leased to Assignor the CAR, NC, and NCAR unpatented mining claims. 
**8. Governing Law.** This Assignment shall be governed by and construed in accordance with the laws of the State of Nevada.
