DEED AND ASSIGNMENT

This Deed and Assignment (this "Deed") is made effective as of April 20, 2022 (the "Effective Date"), by and between FAD MINING COMPANY, LLC, a Nevada limited liability company ("Grantor"), and GOLDEN HILL MINING LLC, a Delaware limited liability company whose address is 1100 Russell Street, Suite 100, Thunder Bay, Ontario, Canada P7B 5N2 ("Grantee"). Grantor and Grantee are sometimes collectively referred to herein as the "Parties" and individually as a "Party".

RECITALS

- Grantor, as the successor in interest to Ruby Hill Mining Company, LLC pursuant Α. to an unrecorded Assignment dated May 14, 2021, and Grantee are among the parties to that certain Master Transaction Agreement dated March 31, 2021, as amended by that certain First Amendment to Master Transaction Agreement dated May 14, 2021, that certain Second Amendment to Master Transaction Agreement dated September 27, 2021, that certain Third Amendment to Master Transaction Agreement dated December 22, 2021, and that certain Fourth Amendment to Master Transaction Agreement dated March 25, 2022 (as so amended, the "Option Agreement").
- Grantor is the owner of the patented mining and millsite claims described in Exhibit 1 hereto (the "Patented Claims"), which Patented Claims are located in Eureka County, Nevada.
- C. Grantor is the owner of the unpatented mining claims described in Exhibit 2 hereto (the "Unpatented Claims"), which Unpatented Claims are located in Eureka County, Nevada.
- Grantor is the lessee under the mining lease agreements described in Exhibit 3 hereto (the "Leases"). The Leases concern the patented and unpatented mining claims described in Exhibit 3 hereto (the "Leased Claims"), which Leased Claims are located in Eureka County, Nevada.
- The Patented Claims and the Unpatented Claims are sometimes referred to herein collectively as the "Owned Claims." The Owned Claims and the Leased Claims are sometimes referred to herein collectively as the "Claims."

F. Grantee has exercised its option under the Option Agreement and the Parties therefore desire to execute this Deed in order to fulfill, in part, their obligations under the Option Agreement.

- 1. <u>Conveyance and Assignment</u>. Grantor does hereby transfer, convey and assign to Grantee all of Grantor's rights, title, interests and obligations in, to and under (a) the Owned Claims and (b) the Leases, together with any and all dumps, tailings and stockpiles located on the Owned Claims, any and all improvements, fixtures, buildings, structures and facilities situated on the Owned Claims, and all mineral rights, rights-of-way, easements, access rights, ancillary rights and other appurtenances with respect to the Owned Claims; EXPRESSLY RESERVING, however, unto Grantor and its successors and assigns the Retained Properties (as defined in the Option Agreement), any water rights appurtenant to the Claims or to the Retained Properties, any Reclamation Bonds (as defined in the Option Agreement) pertaining to the Claims or to the Retained Properties, and any Environmental Permits (as defined in the Option Agreement) pertaining to the Claims or to the Retained Properties, in accordance with Section 9.2 of the Option Agreement.
- 2. <u>Acceptance of Assignment</u>. Grantee hereby accepts the foregoing transfer, conveyance and assignment and hereby expressly and fully assumes and agrees to perform all of Grantor's past, present and future obligations as lessee under the Leases. Grantee acknowledges and agrees that it is bound by and will perform all of the covenants, conditions and other provisions of the Leases to the same extent as if Grantee had been an original party to the Leases.
- 3. <u>Underlying Agreement</u>. This Deed is given in accordance with and pursuant to the Option Agreement, the terms and conditions of which shall survive the execution and delivery of this Deed. In the event of any conflict between the terms of this Deed and the terms of the Option Agreement, the terms of the Option Agreement shall prevail and govern.
- 4. <u>Warranties</u>. In executing and delivering this Deed, Grantor makes only those warranties expressly set forth in the Option Agreement and does not make, and expressly disclaims, any other warranties whatsoever (whether express, implied or applicable by law) concerning the Claims or the Leases. This conveyance is subject to the paramount title of the United States of America in and to those Claims that are unpatented.
- 5. <u>Further Assurances</u>. The Parties agree to execute and deliver such additional documents and to take such other actions as may be reasonably necessary to fully accomplish the transfer of rights and assumption of obligations meant to be effected by this Deed.
- 6. <u>Authority</u>. Each Party represents to the other that (a) it is an entity in good standing under the laws of the state of its formation, (b) the person signing this Deed on its behalf has full and proper authority to do so, (c) it has undertaken and obtained whatever internal and external

formalities, approvals and actions are necessary to execute and deliver this Deed, and (d) this Deed is valid and binding on it.

- 7. Governing Law. This Deed, and any causes of action arising out of or based upon this Deed, shall be governed by, and construed, interpreted and enforced in accordance with, the laws of the State of Nevada, without regard to choice or conflict of law principles that would result in the application of the laws of any other jurisdiction. Each Party irrevocably consents, on behalf of itself and its successors, to the exclusive jurisdiction of the courts of the State of Nevada or the federal district court for the District of Nevada, as may be applicable, in respect of any disputes arising hereunder, with venue to be in Washoe County, Nevada. This Deed shall be construed as if both Parties jointly drafted each of its provisions.
- 8. <u>Binding Effect</u>. This Deed shall inure to the benefit of and be binding upon the Parties and their respective successors and assigns.
- 9. <u>Counterparts</u>. This Deed may be executed in counterparts, which taken together shall constitute a single and complete instrument.
