

THE COURT FINDS as follows:

1. Edward Michael McGrath, III, died on October 25, 2021, in San Clemente,
19 County of Orange, California.

2. Edward Michael McGrath, III died intestate, and his estate was probated in the
21 State of California, however, there was one piece of real property located in Eureka County,
22 Nevada (APN 005-400-21) ("Property"), that needed to be transferred to Decedent's Son,
23 Brandon Michael McGrath.

3. At the time of the death of Edward Michael McGrath, III, he had a Surviving
25 Spouse, Renee Adams Eyzaguirre. Renee Adams Eyzaguirre relinquished any interest in the
