### FIRST AMENDMENT TO MINING LEASE

This First Amendment to Mining Lease ("Amendment ") is made effective the 23 day of June, 2022, by and between **Nevada Gold Mines LLC**, a Delaware Limited Liability Company corporation ("Lessee"), and **Genesis Gold Co. in care of Metalla Royalty and Streaming Ltd.**, ("Lessor"). Collectively, Lessor and Lessee shall be referred to as the Parties.

### RECITALS

- A. Lessor and Lessee as successor in interest to Placer Dome U.S. Inc., entered into a Mining Lease dated June 28, 2002 (the "Lease"), the short Form was recorded at Book 348, Page 361, as Entry No. 178396 in the official records of the Eureka County recorder, Nevada on July 25, 2002;
  - B. The Parties desire to amend the Lease and extend the Term as set forth below;

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree that the Mining Lease is amended in the following respects:

- 1. Terms used herein and not otherwise defined shall have the meaning ascribed to them in the Mining Lease.
- 2. Section 6.1 - Term of Agreement is hereby deleted and replaced with the following:

This Lease shall remain in effect in effect for twenty-one (21) years (for greater certainty, until June 28, 2023) and so long thereafter as any exploration,

development, mining processing or marketing operations are carried out on or with respect to the Claims in good faith on a continuous basis (the "Term"). This Lease may earlier terminate pursuant to Sections 6.3 and 6.4. For purposes of this Section 6.1, operations and activities shall be deemed to have been carried out on a "continuous basis" so long as they do not cease for a period of more than 365 consecutive days.

3. For greater certainty, Advance Mining Royalty payments shall continue in full force and effect under section 3.2 at the current rate of \$100,000.00 per year for the full extension of the lease and any subsequent extensions.
4. Section 8.6 is hereby amended to replace the address for notice to Genesis as follows:


