SUBSTITUTION OF TRUSTEE AND RECONVEYANCE OF DEED OF TRUST

Computershare Trust Company, N.A., as Collateral Agent for the benefit of the Lenders under that certain Fifth Amended and Restated Credit Agreement dated July 16, 2018 (“Beneficiary”), is the holder of that certain indebtedness described in that certain Deed of Trust With Power of Sale, Assignment of Production, Security Agreement, Financing Statement Fixture Filing dated October 31, 2018 (together with all amendments thereto, the “Deed of Trust”), from Klondex Gold & Silver Mining Company, a Nevada corporation, as trustor (“Trustor”), to First American Title Company, as trustee, for the benefit of Beneficiary, as beneficiary recorded in the Office of the Eureka County Recorder, Nevada, on November 26, 2018, as Document No. 2018-236437.



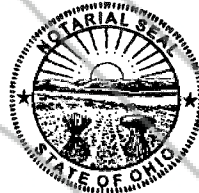
