regulations, and by this affidavit, Owner intends to hold and maintain each of the Claims through the assessment year ending September 1, 2023.



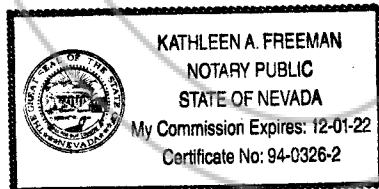
