ORDER

18 The Court, upon the stipulation and settlement of the parties, hereby
19 enters this order regarding the division of property and mineral rights of the parties,
20 **PETE M. PETERS and MARCIA L. SCOTT, individually and as Managing**
21 **Member of JIGGS BAR, LLC,** hereby enters the following orders:

22 1. That the Settlement Agreement and Mutual Release entered into
23 between the parties is hereby adopted by the Court.

24 2. That all causes of action in the Complaint and Counterclaim are
25 hereby dismissed with prejudice.

26 4. That **PETE ELIA and LEONI ELIA**, husband and wife, owned as
27 community property specific mineral rights located in White Pine County, Nye County,
28 Eureka County and Elko County, Nevada (the "property").

1 5. That upon **PETE ELIA's** death, an undivided one-half interest in
2 and to the property and interests became the interest of the **ESTATE OF PETE**
3 **ELIA**, and an undivided one-half interest was confirmed in **LEONI ELIA** as the
4 surviving spouse, in accordance with that certain Decree filed March 27, 1981, recorded
5 with the Office of the County Recorder of the County of Elko, State of Nevada, as Doc.
6 No. 80038.

7 6. That by that Decree, the parties, **PETE M. PETERS** and
8 **MARCIA L. SCOTT**, were each the rightful owners the specific mineral rights which
9 were the located in White Pine County, Nye County, Eureka County and Elko County,
10 Nevada, as follows:

11 PETE M. PETERS	1/4 interest in and to ESTATE OF PETE ELIA
12 MARCIA L. SCOTT	1/4 interest in and to ESTATE OF PETE ELIA
13 ISABEL PETERS	1/2 interest in and to ESTATE OF PETE ELIA

14 7. That **LEONI ELIA** then conveyed her one-half interest, which was
15 her community property interest in and to the specific mineral rights located in White
16 Pine County, Nye County, Eureka County and Elko County, Nevada, to herself and
17 **ISABEL PETERS**, as joint tenants with right of survivorship, by that certain Deed
18 dated January 20, 1983, recorded with the Office of the County Recorder of the County
19 of Elko, State of Nevada, on January 21, 1983, as Doc. No. 172735.

20 8. That upon the death of **LEONI ELIA**, **ISABEL PETERS** became
21 the rightful owner of all of the interest (an undivided 1/2 interest) which had been held
22 by **ISABEL PETERS** as community property, which then merged with her one-half
23 interest in and to the specific mineral rights which had been held by the **ESTATE OF**
24 **PETE ELIA** (an undivided one-fourth interest), totaled an undivided three-fourths
25 interest in and to the specific mineral rights which had been once held by both **PETE**
26 **ELIA** and **LEONI ELIA**, as community property.

27 3. That any interests of the following decedents, **ISABEL PETERS aka**
28 **ISABEL FAY PETERS** and **HARRY W. PETERS aka HARRY WADSWORTH**

1 **PETERS**, which comprise an undivided three-fourths interest, in and to the following
2 property (mineral rights) is ordered distributed to **PETE M. PETERS** as to an
3 undivided 50% interest in the property and **MARCIA L. SCOTT** as to an undivided
4 50% interest in the following property, as tenants in common:
