**SPECIAL WARRANTY DEED CONVEYING
INTERESTS IN OVERRIDING ROYALTY**

This Special Warranty Deed Conveying Interests in Overriding Royalty (this "**Deed**") is made effective as of December 30, 2022 (the "**Effective Date**"), from **TIMOTHY WILSON, AS TRUSTEE OF THE TIMOTHY WILSON FAMILY TRUST UNDER THE TRUST AGREEMENT DATED APRIL 9, 2014** (the "**Grantor**"), whose address is 490 Genovese Lane, Reno, Nevada 89511, to **RG ROYALTIES, LLC**, a Delaware limited liability company (the "**Grantee**"), whose address is 1144 15th Street, Suite 2500, Denver, Colorado 80202.

I.

RECITALS AND DEFINED TERMS

1.1 Grantor's predecessors, among others, being the successors in interest to Idaho Mining Corporation, a dissolved corporation (the "**Idaho Successors**"), were parties to the following conveyances and agreements under which certain net profit interests were converted into overriding royalty interests or were otherwise diminished:

a. Special Warranty Deed Conveying Overriding Royalty Interest dated June 30, 1993, recorded in Book 396, commencing at Page 23 in Lander County, and Book 248, commencing at Page 284 in Eureka County, as corrected by Correction Special Warranty Deed Conveying Overriding Royalty Interest dated August 9, 1993, recorded in Book 400, commencing at Page 328 in Lander County, and in Book 253, commencing at Page 405 in Eureka County (referred to herein as the "**Royalty Deed**").

b. Special Warranty Deed and Bill of Sale dated June 30, 1993, recorded in

Book 396, commencing at Page 160 in Lander County, and in Book, 248, commencing at Page 422 in Eureka County, as corrected by Correction Special Warranty Deed and Bill of Sale dated August 9, 1993, recorded in Book 400, commencing at Page 599 in Lander County, and in Book 254, commencing at Page 142 in Eureka County.

c. Special Warranty Deed Conveying Interest in Overriding Royalty from Grantor's predecessor, and others of the Idaho Successors, to Placer Dome U.S. Inc. and Kennecott Exploration (Australia) Ltd., dated June 30, 1993, recorded in Book 396, commencing at Page 276 in Lander County, and in Book 249, commencing at Page 1 in Eureka County, as corrected by Correction Special Warranty Deed Conveying Interest in Overriding Royalty dated August 9, 1993, recorded in Book 400, commencing at Page 458 in Lander County, and in Book 254, commencing at Page 001 in Eureka County (referred to herein as the "**Placer-Kennecott Deed**").

d. Memorandum of Surviving Provisions of the Exchange Agreement dated June 30, 1993, recorded in Book 396, commencing at Page 151 in Lander County, and in Book 248, commencing at Page 412 in Eureka County, as corrected by Corrected Memorandum of Surviving Provisions of Exchange Agreement dated August 9, 1993, recorded in Book 400, commencing at Page 589 in Lander County, and in Book 254, commencing at Page 132 in Eureka County.

e. Exchange Agreement dated June 30, 1993, as amended by First Amendment of Exchange Agreement dated August 9, 1993, memoranda of which are recorded as set forth in subparagraph D above.

f. Clarification Agreement dated August 11, 1995, between the Cortez Joint Venture, Cortez Gold Mines, Placer Dome U.S. Inc., Kennecott Exploration (Australia), Ltd., Idaho Resources Corporation and the Idaho Successors, recorded in Book 421, commencing at Page 205 in Lander County, and in Book 287, commencing at Page 552 in Eureka County.

The instruments listed above in subparagraphs 1.1(a) through 1.1(f) are incorporated herein by reference and, hereinafter, referred to collectively as the "**Idaho Conversion Documents**."

1.2 The rights, titles and interests conveyed to the Idaho Successors by the Idaho Conversion Documents, including as such rights, titles and interests were diminished by the portion of those rights, titles and interests conveyed by the Idaho Successors, as applicable, under the Placer-Kennecott Deed, the Royal Gold Deeds (as defined in Section 1.4(d) below), and the Barrick Deed (as defined in Section 1.4(i) below), are referred to in this Deed as the "**Royalty Interests**." The Royalty Interests apply to the "**Subject Property**" as defined in the Royalty Deed, and such definition is adopted for relevant purposes of this Deed. Grantor's right, title and interest in the Royalty Interests as set forth in Exhibit "A" attached to and made a part of this Deed (under the heading "*Subject Interest*") is referred to herein as the "**Subject**

Interest.”

1.3 Grantor owns an undivided right, title and interest in and to 100% of the Subject Interest.

1.4 Grantor acquired its right, title and interest in and to the Subject Interest pursuant to the following conveyances and agreements:

a. Conveyance and Assignment dated December 1, 1993, by Denver G. Cherry, as Trustee of the Cortez Interest Trust, to Timothy King Wilson, individually, et al., recorded in the Office of the Eureka County on January 25, 1994, in Book 263 of Official Records, Page 582, as Document No. 150200, and in the Office of the Lander County Recorder on January 5, 1994, in Book 404 of Official Records, Page 204, as Document No. 187447.

b. Assignment dated December 11, 1996, by JoAnn K. Wilson, as Trustee of the 1988 Trust dated March 2, 1988, to JoAnn Wreisner Curtis, Trustee of the JoAnn Wreisner Curtis 1988 Trust, as amended December 11, 1996, recorded in the Office of the Eureka County Recorder on May 27, 1997, in Book 308 of Official Records, Page 166, as Document No. 166868, and in the Office of the Lander County Recorder on May 19, 1997, in Book 441 of Official Records, Page 526, as Document No. 202951.

Special Warranty Deed dated September 1, 1999, by JoAnn Wreisner Curtis as Trustee of the JoAnn Wreisner Curtis 1988 Trust, as amended December 11, 1996, to Royal Gold, Inc., a Delaware corporation, recorded in the Office of the Lander County Recorder on September 3, 1999, in Book 468 of Official Records, Page 002, as Document No. 213249.

d. Special Warranty Deed dated September 1, 1999 (together with the Special Warranty Deed referred to in paragraph (c) of this Section 1.4, collectively, the “**Royal Gold Deeds**”), by Timothy King Wilson and Denise Wilson, his wife, to Royal Gold, Inc., a Delaware corporation, recorded in the Office of the Lander County Recorder on September 3, 1999, in Book 468 of Official Records, Page 080, as Document No. 213255.

e. The “2000 Assignments” described in the Affidavit of Trustee, recorded in the Office of the Eureka County Recorder on December 7, 2005, in Book 429 of Official Records, Page 13, as Document No. 202507, and in the Office of the Lander County Recorder on December 13, 2005, in Book 549 of Official Records, Page 770, as Document No. 0239941.

f. Special Warranty Deed dated December 5, 2005, by William A. Curtis, Jr., as Trustee of the Curtis Family Trust of 2000, Under Declaration of Trust dated December 8, 2000, as amended, to William A. Curtis, Jr., as Trustee of "Trust B" of the Curtis Family Trust of 2000, pursuant to the Declaration of Trust dated December 8, 2000, as amended, Timothy K. Wilson, individually, and Gregory A. Wilson, individually, recorded in the

Office of the Eureka County Recorder on December 7, 2005, in Book 429 of Official Records, Page 32, as Document No. 202508, and in the Office of the Lander County Recorder on December 13, 2005, in Book 549 of Official Records, Page 789, as Document No. 0239942.

Special Warranty Deed dated October 31, 2008 (the "**Barrick Deed**"), by Timothy King Wilson, individually, to Barrick Cortez Inc., a Nevada corporation, recorded in the Office of the Eureka County Recorder on November 3, 2008, in Book 482 of Official Records Page 067, as Document No. 0212707, and in the Office of the Lander County Recorder on November 3, 2008, in Book 592 of Official Records, Page 1130, as Document No. 0253074.

j. Notice of Termination of Life Estate dated as of September 25, 2019, confirming the termination of the life estate created under the deeds referred to in paragraphs (g) and (h) of this Section 1.4 and reverting the interest, recorded in the Office of the Eureka County Recorder on October 4, 2019, as Document No. 2019-239607, and in the Office of the Lander County Recorder on October 7, 2019, as Document No. 291294.

k. Certification of Successor Trustee dated October 15, 2019, by Steve S. Johnson in accordance with NRS 164.400 through 164.440, confirming his authority as successor of each of William A. Curtis, Jr., and the Whittier Trust Company of Nevada, Inc., as sole trustee of the Marital Trust – Trust B under the Curtis Family Trust of 2000, recorded in the Office of the Eureka County Recorder on October 17, 2019, as Document No. 2019-239627, and in the Office of the Lander County Recorder on October 18, 2019, as Document No. 291331.

Johnson, as Trustee of GST Non-Exempt Marital Trust - Trust B under the Curtis Family Trust of 2000, under the Declaration of Trust dated December 8, 2000, to Timothy Wilson, as Trustee of the Timothy Wilson Family Trust under the Trust Agreement dated April 9, 2014, recorded in the Office of the Eureka County Recorder on March 2, 2020, as Document No. 2020-240114, and in the Office of the Lander County Recorder on March 2, 2020, as Document No. 292952.

n. Royalty Deed dated March 11, 2020, by Timothy K. Wilson to Timothy Wilson, as Trustee of the Timothy Wilson Family Trust under the Trust Agreement dated April 9, 2014, recorded in the Office of the Eureka County Recorder on March 13, 2020, as Document No. 2020-240317, and in the Office of the Lander County Recorder on March 13, 2020, as Document No. 292997.

1.5 Grantee has offered to purchase, and Grantor has agreed to sell, an undivided fifty percent (50%) of Grantor's right, title, and interest in and to the Subject Interest, subject to, or which may become subject to, the Idaho Conversion Documents (sometimes referred to herein as the "Sale Interest").

1.6 Wherever the context so requires in this Deed, use of a masculine word form shall include the feminine or neuter forms thereof, use of a singular form shall include the plural and vice versa.

II. **CONVEYANCE**

2.1 For and in consideration of Ten Dollars (\$10), and other good and valuable consideration received from Grantee, the receipt and sufficiency of which is acknowledged by Grantor, Grantor hereby grants, bargains, sells, deeds, conveys, and assigns to Grantee, and Grantee's successors and assigns forever, the Sale Interest, subject to, or which may become subject to, the Idaho Conversion Documents. For the purpose of clarity, Grantor specifically reserves and retains to itself, its personal representatives, heirs, and assigns the remaining undivided fifty percent (50%) of Grantor's right, title, and interest in and to Grantor's Subject Interest.

III. **MISCELLANEOUS**

3.1 This Deed is subject to the restraints and obligations imposed upon Grantor by the provisions of the Idaho Conversion Documents, and Grantee takes title to the right, title and interest hereby conveyed to it subject to those restraints and obligations.

3.2 Grantor shall promptly notify each current payor in respect of the Royalty Interests that all royalty payments in respect of the Sale Interest payable on or after January 1, 2023 shall be made to Grantee.

3.3 Grantor warrants title to the right, title and interest conveyed to Grantee by this Deed against, but only against, any person or entity lawfully claiming the whole or any part thereof by, through or under Grantor, but not otherwise.

3.4 The right, title and interest conveyed to Grantee by this Deed shall attach and pertain to all of the mining claims, mineral rights, leases and other properties comprising or within the Subject Property, to any locations, amendments or relocations of the mining claims, mineral rights, leases and other properties comprising or within the Subject Property and also to any other mining claims, mineral rights, properties or leases which may be made subject to the Royalty Interests from time to time pursuant to the Idaho Conversion Documents. The Subject Interest shall attach and pertain to the full extent of the Grantor's rights in the Subject Property. No new or changed reference to any area of the Subject Property (including by royalty 'region'), whether now or at any future date, shall alter the nature or extent of the Subject Interest or Grantee's right, title and interest therein.

3.5 Grantor shall execute such other documents and give such further assurances, if any become necessary, in order to effectuate and carry out the full intents and purposes of this Deed.

3.6 The provisions of this Deed shall be binding upon and shall inure to the benefit of Grantor and Grantee and their respective successors, assigns, personal representatives, and heirs.
