

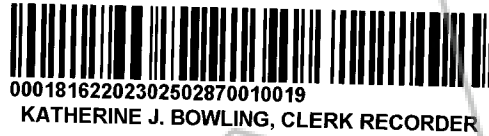

Said locator is the proprietor or owner of the BTO, NEE, & ZEKE (un)patented mining claims generally located in Eureka County, Nevada.

The Mill Site is approximately 660 feet in the northerly-southerly direction and 330 feet in the easterly-westerly direction. Said Mill Site contains 5 acres, more or less. The monument of location is located at the NE corner of the Mill Site.

As erected on the ground, each corner monument is marked as described above by scribed metal tags.

The boundaries of said claim were defined by law within sixty days from the date of posting of the Notice of Location. The location work, consisting of the making and filing of maps and the payment of fees prescribed by NRS 517.040, was completed by the date of recordation of this certificate.

This mill site location is made without any intent to waive or abandon any rights acquired by virtue of the lode mining claims previously located on this land. It is the intent of the locator to locate this land, under the applicable law as well as to secure mill site rights while the locator advances the geologic understanding of the claim area.
