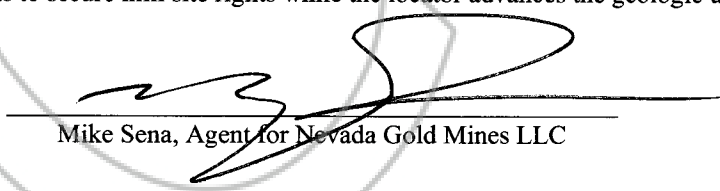

As erected on the ground, each corner monument is marked as described above by scribed metal tags.

The boundaries of said claim were defined by law within sixty days from the date of posting of the Notice of Location. The location work, consisting of the making and filing of maps and the payment of fees prescribed by NRS 517.040, was completed by the date of recordation of this certificate.

This mill site location is made without any intent to waive or abandon any rights acquired by virtue of the lode mining claims previously located on this land.
