in Eureka County, Nevada, on March 17, 2023.

Said locator is the proprietor or owner of the BTO, NEE, & ZEKE (un)patented mining claims generally located in Eureka County, Nevada.

The Mill Site is approximately 660 feet in the northerly-southerly direction and 330 feet in the easterly-westerly direction. Said Mill Site contains 5 acres, more or less. The monument of location is located at the SW corner of the Mill Site.
