dated November 18, 2005.



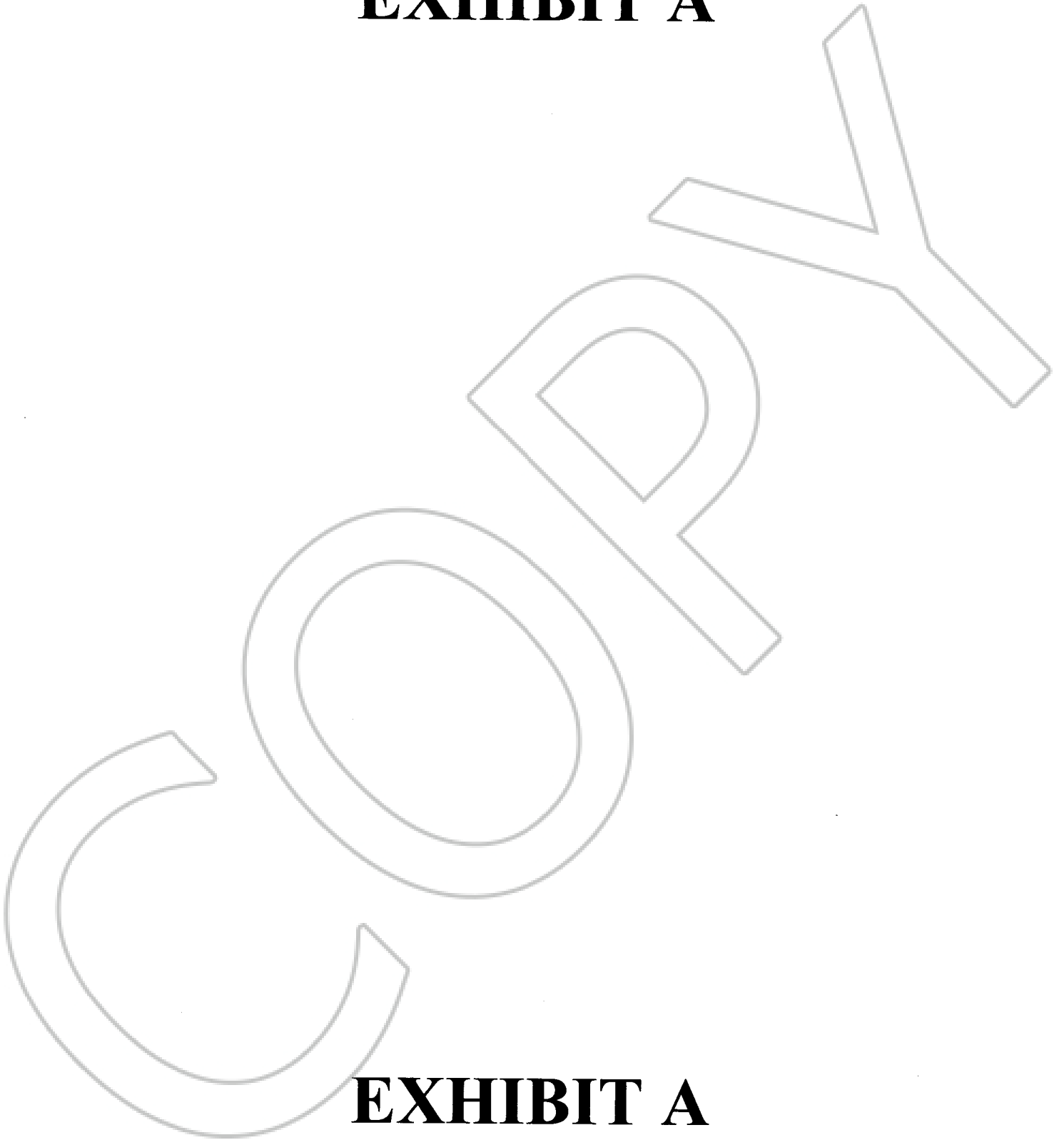
