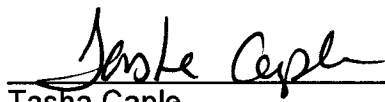
Being duly authorized, I make this affidavit on behalf of Nevada Gold Mines LLC, 1655 Mountain City Highway, Elko, Nevada, 89801, United States.

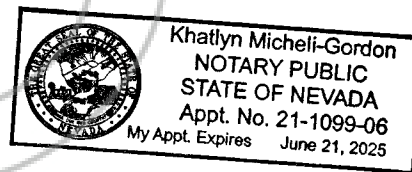
