for the assessment year ending September 1, 2023.



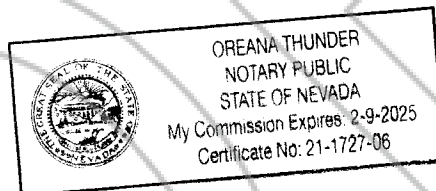
