14 In this action, the Defendant, BRUCE K. COPEN, having been served the Summons and
15 Complaint by service of process by publication, and having failed to appear and answer the
16 Plaintiff's Complaint filed herein, the legal time for answering having expired, the default of the
17 above named Defendant, BRUCE K. COPEN, in the premises, having been duly entered according
18 to law, and it appearing that said Defendant is not in the military service of the United States and is
19 not an infant nor incompetent persons; upon application of the Plaintiff, ELKO FEDERAL
20 CREDIT UNION, and upon hearing on the default judgment, a Judgement is hereby entered
21 against said Defendant, BRUCE K. COPEN, pursuant to the prayer of said Complaint.

22 **WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED** that the

Pursuant to Plaintiff's Second and Fourth Claims for Relief, the sum of Forty-One Thousand Eight Hundred Fifty-Two Dollars and Sixty-Two Cents (\$41,852.62), together with 6.25% (annual percentage rate) interest thereon from October 31, 2022 until paid in full, and late fees in the sum of One Hundred Fifteen Dollars (\$115.00);

3. Plaintiff's costs in the amount of Five Hundred Ninety-Eight Dollars and Sixty-Six Cents (\$598.66);

4. Plaintiff's reasonable attorneys' fees to date, pursuant to the contract between the parties, in the amount of Five Thousand Five Hundred Twenty Dollars (\$5,520.00); and,

5. Plaintiff's future reasonable attorneys' fees and costs for the collection and satisfaction of this Judgment.
