
**SUBSTITUTION OF TRUSTEE

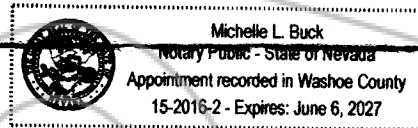
