22 along, across, and through the said land for the purposes of erecting, constructing,
23 operating, repairing and maintaining pole lines with cross arms for the transmission
24 of electrical energy, and for telephone lines, and/or for laying, repairing, operating,
25 and renewing any pipe line or line for water, gas or sewage, and any conduits for
26 electric or telephone wires, and reserving the sole right to convey the rights hereby
