10. That this judgment is not a foreign judgment or from an abstract of judgment from another county or state.



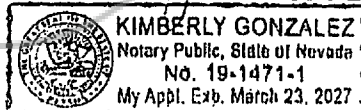
