CERTIFICATE OF LOCATION

Lode Mining Claim

NOTICE IS HEREBY GIVEN that **Clear Canyon LLC**, 5470 Kietzke Lane, Suite 300, Reno, NV 89511, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described **LODE MINING CLAIM**:

The name of the claim is the **BDW 748**.

This claim was located on **May 11, 2024**, by posting a Location Notice at the discovery monument.
