CERTIFICATE OF LOCATION

Lode Mining Claim

NOTICE IS HEREBY GIVEN that **Clear Canyon LLC**, 5470 Kietzke Lane, Suite 300, Reno, NV 89511, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described **LODE MINING CLAIM**:

The name of the claim is the **BDW 927**.

This claim was located on **May 8, 2024**, by posting a Location Notice at the discovery monument.

The length of the claim is **10** feet in a **easterly** direction and **1490** feet in the opposite direction from the monument where the Location Notice is posted, and the width is **300** feet on each side of the center of the vein or lode, comprising in all **1500** feet in length and **600** feet in width, and generally following a **easterly-westerly** course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument consists of a 2" x 2" x 4' wooden post with aluminum tags attached, scribed with claim name and corner description, set one foot in the ground.
