

MEMORANDUM OF GEOTHERMAL AND SURFACE USE LEASE

THIS MEMORANDUM OF GEOTHERMAL AND SURFACE USE LEASE (this "Memorandum") is entered into as of the 1st day of May, 2024, by and between New Nevada Resources, LLC, whose address at 4405 Commons Drive East, Suite 301, Destin, Florida 32541, a Florida Limited Liability Company ("Lessor") and Norte Geothermal LLC, a Nevada Limited Liability Company, whose address is 701 S Carson St. Ste 200, Carson City, NV 89701 ("Lessee").

Lessor has leased to Lessee the that certain real property located in Elko/ Eureka County, Nevada, more particularly described in **Exhibit "A"** attached hereto and incorporated herein by this reference (the "**Property**"), upon the terms and conditions set forth in that certain Geothermal and Surface Use Lease dated as of May 1, 2024 (the "**Effective Date**"), by and between Lessor and Lessee (the "**Lease**"). The Lease also includes the Geothermal Substances under the Property.
