**SHORT FORM DEED OF TRUST  
(Water Rights)**

THIS SHORT FORM DEED OF TRUST ("Deed of Trust"), made this 29 day of August, 2024, between, McEwen Mining Nevada Inc., a Delaware corporation, as TRUSTOR ("Trustor"), Stewart Title Company, as TRUSTEE ("Trustee"), and Richard James Kniefel and Anne Barbara Kniefel, individuals (collectively, "Beneficiary").

WITNESSETH: That Trustor grants to Trustee in trust, with power of sale, those certain water rights in the COUNTY OF EUREKA, STATE OF NEVADA as described on Exhibit A ("Property"), which is attached hereto and incorporated herein by this reference.

IN THE EVENT THE HEREIN DESCRIBED PROPERTY, OR ANY PORTION THEREOF, OR ANY INTEREST THEREIN, IS SOLD, AGREED TO BE SOLD, CONVEYED, ALIENATED, BANKED, OR DEDICATED BY THE TRUSTOR, OR BY THE OPERATION OF LAW OR OTHERWISE, ALL OBLIGATIONS SECURED BY THIS INSTRUMENT, IRRESPECTIVE OF THE MATURITY DATES EXPRESSED THEREIN, AT THE OPTION OF THE HOLDER HEREOF AND WITHOUT DEMAND OR NOTICE SHALL IMMEDIATELY BECOME DUE AND PAYABLE.

This Deed of Trust is made for the purpose of securing (1) payment of the sum of Two Hundred Seventy Thousand and 00/100 (\$270,000.00) with interest thereon, as evidenced by that certain Secured Promissory Note of even date herewith (the "Note") made by Trustor, as borrower, payable to order of Beneficiary, as lender, and all extensions or renewals thereof; (2) the performance of each obligation of Trustor under the Note; (3) the performance of each agreement of Trustor, incorporated herein by reference or contained herein; and (4) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada on January 30, 1968, in the book and at the page thereof, or under the document or file number, noted below opposite the name of such county: namely:

In addition to and without limiting any of the foregoing, to the extent applicable, the following covenants, Nos. 2 and 7 of NRS 107.030 are hereby adopted and made a part of this Deed of Trust and reference to "improvements which are now or shall hereafter be erected upon the premises" shall be interpreted to mean any improvements related to the use of or access to the water rights that are the subject of this Deed of Trust. With respect to covenant number 2, "full replacement value" is hereby inserted. With respect to covenant number 7, "reasonable counsel fees and costs actually incurred" is hereby inserted.

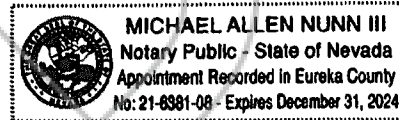
