

All such maintenance fees are paid on behalf of the OWNER.

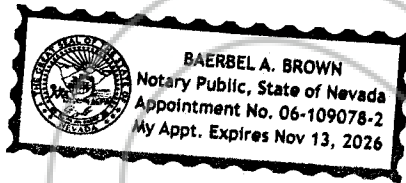


