

Claims: Coulton 1 thru Coulton 10 (total of 10 lode mining claims)
Located: Lynn Mining District, Eureka County, Nevada

Work conducted: August 27,28,29, 2024

The geophysics survey was conducted on all of the above mentioned lode mining claims. Fifteen survey lines were run east-west to claim boundaries using a Geonics EM-16 VLF. The survey was successful in delineating the geological structural trends represented by VLF conductor zones. A relatively strong anomaly running N-S thru the center of the claim block is represented by swarm of North trending closely spaced structures steeply dipping to the west. Weaker anomalies run parallel to sub-parallel to the stronger central anomaly across the claim block.
