5. The federal annual mining claim maintenance fee for the assessment year ending on September 1, 2025 was paid on August 15, 2024 .

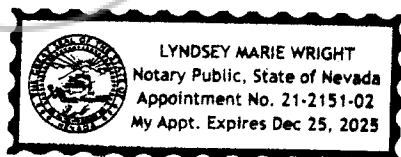
