
RECITALS:

- 3. <u>Further Assurances</u>. Assignor covenants and agrees, at its own expense, to execute and deliver, at the reasonable request of Assignee, such further instruments of transfer and assignment, and to take such other action as Assignee may reasonably request to more effectively consummate the assignments and assumptions contemplated in this Assignment.

- 4. <u>Governing Law</u>. The provisions of this Assignment shall be governed by and construed under the laws of the State of South Carolina (without giving effect to its principles of conflict of laws).
- 5. <u>Counterparts</u>. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
