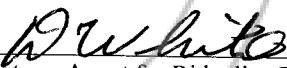

No. 3: Southeast Corner	SE Corner <u>BOB 45</u>	2" X 2" X 4' wood post
No. 4: Southwest Corner	SW Corner <u>BOB 45</u>	2" X 2" X 4' wood post

As erected on the ground, each corner monument is marked as described above by a scribed metal tag.
