

Termination of Royalty Deed and Agreement

This Termination of Royalty Deed and Agreement (this "Termination") is made effective the date stated below by NuLegacy Gold Corporation, a British Columbia corporation (the "Royalty Holder"), to and for the benefit of NuLegacy Gold Corporation NV, a Nevada corporation ("NuLegacy NV").

Recitals

A. Royalty Holder and NuLegacy NV are parties to the Royalty Deed and Agreement dated April 25, 2023, recorded in the Office of the Eureka County Recorder on November 29, 2023, as Document 2023-252329 (the "Royalty Agreement"), pursuant to which NuLegacy NV granted to Royalty Holder a mineral production royalty (the "Royalty") on the properties described in and subject to the Royalty Agreement.

B. The Royalty Holder and NuLegacy NV desire to formally terminate the NPR.

Now, therefore, in consideration of the promises and covenants of the parties, and for other good and valuable consideration, the receipt and sufficiency of which the parties acknowledge, the Royalty Holder discharges, releases, and terminates the Royalty Agreement and the obligation of NuLegacy NV to pay the Royalty, and the Royalty Holder discharges, releases, and terminates the Royalty Agreement recorded in the Office of the Eureka County Recorder on November 29, 2023, as Document 2023-252329. Royalty Holder's discharge, release and termination applies to each mining claim and property interest described in the Royalty Agreement as the Grantor Properties and any other interest, property or rights which might otherwise have become subject to the Royalty Agreement.


Royalty Holder and NuLegacy NV acknowledge and confirm that NuLegacy NV has not produced any metals or minerals from the Grantor Properties and that NuLegacy NV is not obligated to pay any Royalty or other payments to Royalty Holder under the Royalty Agreement.
