CERTIFICATE OF LOCATION

Lode Mining Claim

NOTICE IS HEREBY GIVEN that **Nedeel LLC, a Nevada limited liability company, Entity No. E0390042018-9**, 400 Fairview Blvd., Unit 11, Incline Village, Nevada 89451, hereby claims under and pursuant to the laws of the State of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is the AP 1.

This claim was located on March 2, 2025, by posting a Location Notice at the discovery monument.

The length of the claim is 10 feet in a easterly direction and 1490 feet in the opposite direction from the monument where the Location Notice is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a easterly-westerly course.
